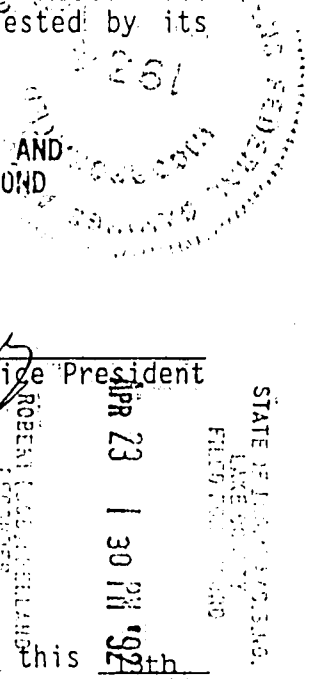
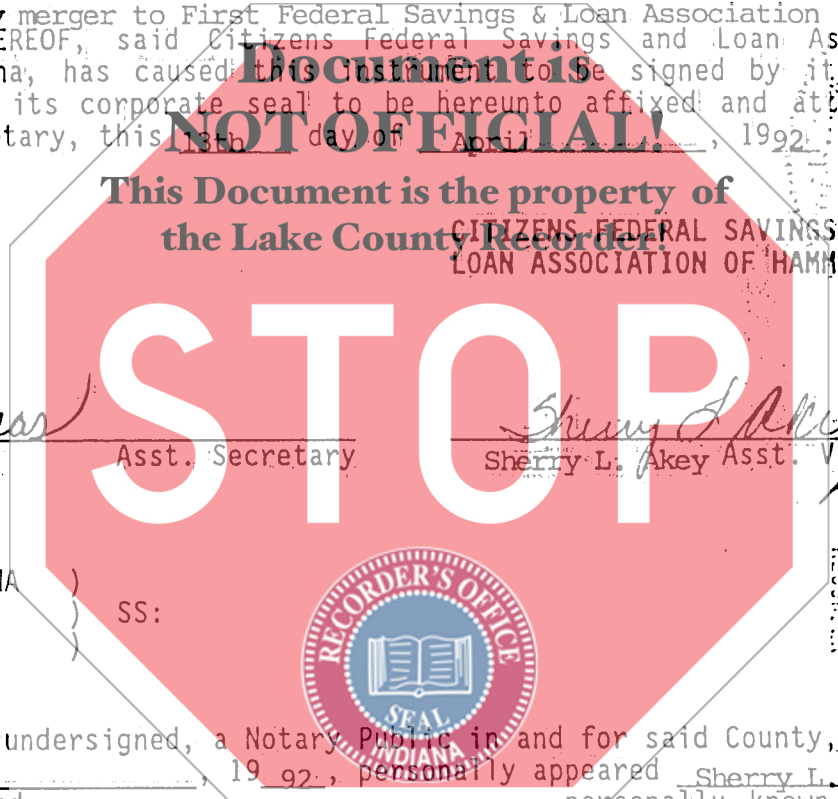

Part of the Northwest $\frac{1}{4}$ of the Southwest $\frac{1}{4}$ of Section 15, Township 35 North, Range 9 West of the 2nd Principal Meridian is described as follows: Beginning at a point on the West line of said section which is 1838.58 feet North of the Southwest corner thereof; thence North 90 degrees East a distance of 790.23 feet to a point; thence North 58 degrees 51' 30" West a distance of 418.82 feet to the point of beginning of the tract herein described; thence Southwesterly at right angles to the last described line a distance of 155 feet; thence North 58 degrees 51' 30" West a distance of 100 feet; thence Northeasterly at right angles to the last described line a distance of 155'; thence Southeasterly 100 feet to the place of beginning, in the Town of Schererville, Lake County, Indiana.
