I, WILLIAM M. LEE, of 547 New Jersey Street, Gary, Indiana, 46403 being of lawful age and of sound and disposing mind and memory, do hereby make, publish and declare this to be my Last Will & Testament, revoking and making null and void all other Wills and Codicils heretofore made by me.

I direct that all my legal debts, my funeral expenses, the expenses of my last illness, if any, and the expenses and charges for the administration of my estate be paid out of my residuary estate as soon as convenient after my death. I further direct that all estate, inheritance, transfer, legacy, gift, succession, and other similar taxes, together with interest and penalties thereon, if any, imposed on or with respect to any property or interest therein, deemed a part of my estate for the purpose of determining any of such taxes, whether or not passing under this Will, shall be paid by my joint Administrators, Andrea Novella Lee, Social Security #313-62-0867 and Sharon Denise Lee, Social Security #311-58-2774, below called my Personal Representatives, from my residuary estate in the same manner as any debt thereof, and my Personal Representatives shall not seek reimbursement for such payment from any person whomsoever. If by the laws exacting such taxes, any beneficiary, legatee, or devisee shall be made personally liable for any of such taxes, my Personal Representatives shall indemnify such beneficiary, legatee, or devisee from the assets of my residuary estate, to the extent of such taxes, together with interest and penalties thereon, if any.

All the rest, residue and remainder of my property, of whatsoever kind and wheresoever situated, but excluding any property over which I may have a power of appointment, it being my intention not to exercise any of appointment, I give, bequeath and devise my residuary estate, in equal shares to my children who survive me, treating as a surviving child the collective issue surviving me of any child of mine who shall have predeceased me, the distribution to such issue to be per capita.

B. In extension and not in limitation of the powers given by law, my Personal Representatives shall have the following powers with respect to the administration and settlement of my estate, to be exercised from time to time in the discretion of my Personal Representatives without order or license of the court:

The distribution of each Certificate of Deposit shall be made directly to the specific individual who is named and/or identified as having joint tenancy in common with the right of survivorship on each Certificate of Deposit.

The distribution of each Life Insurance Policy shall be made directly to the specific grandchild who is named and/or identified on the policy. It is my wish that each grandchild maintain these life insurance policies for their children's college education or until their children reach the age of 21. The \$100,000 life insurance policies are "self-sustaining"; therefore, the premiums are paid by the policy.

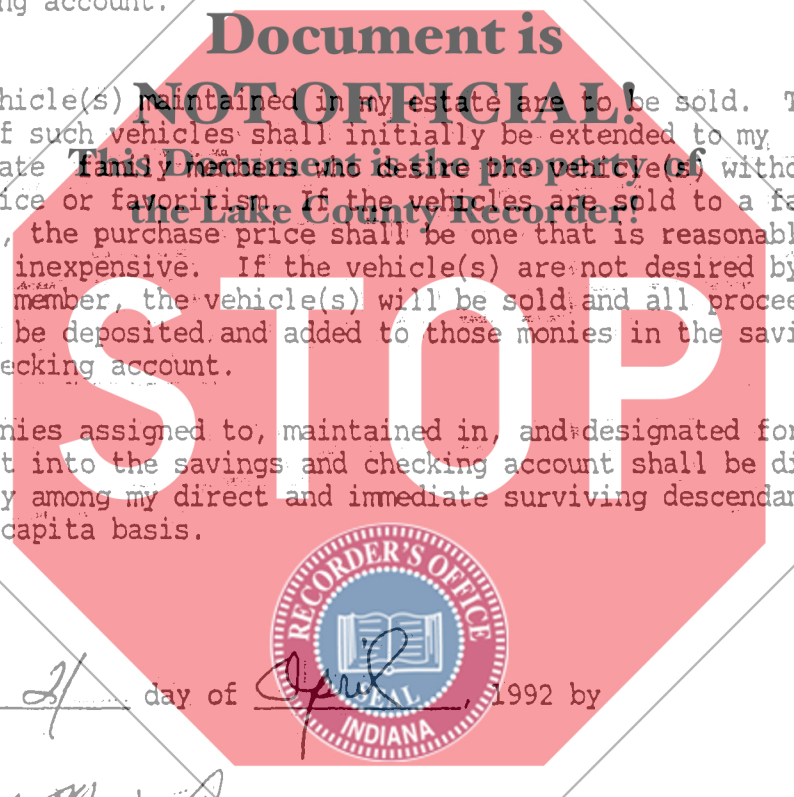
The distribution of all furniture and furnishings in the 547 New Jersey Street, Gary, Indiana location are to distributed as follows:

The yellow living room sofas and crystal lamps will initially be offered to my son, Steven Dwayne Lee at no charge. If Steven does not desire this furniture and no other member of my immediate family desires the furniture, the furniture will be sold and the proceeds are to be deposited and added to those monies in the savings and checking account.

All other furniture and furnishings will be offered to my immediate family members desiring such items at no charge. Remaining furniture and furnishings not selected by my immediate family will be sold and all proceeds are to be deposited and added to those monies in the savings and checking account.

Any vehicle(s) maintained in my estate are to be sold. The sell of such vehicles shall initially be extended to my immediate family members who desire the vehicle(s) without prejudice or favoritism. If the vehicles are sold to a family member, the purchase price shall be one that is reasonable, and/or inexpensive. If the vehicle(s) are not desired by a family member, the vehicle(s) will be sold and all proceeds are to be deposited and added to those monies in the savings and checking account.

All monies assigned to, maintained in, and designated for deposit into the savings and checking account shall be divided equally among my direct and immediate surviving descendants on a per capita basis.
