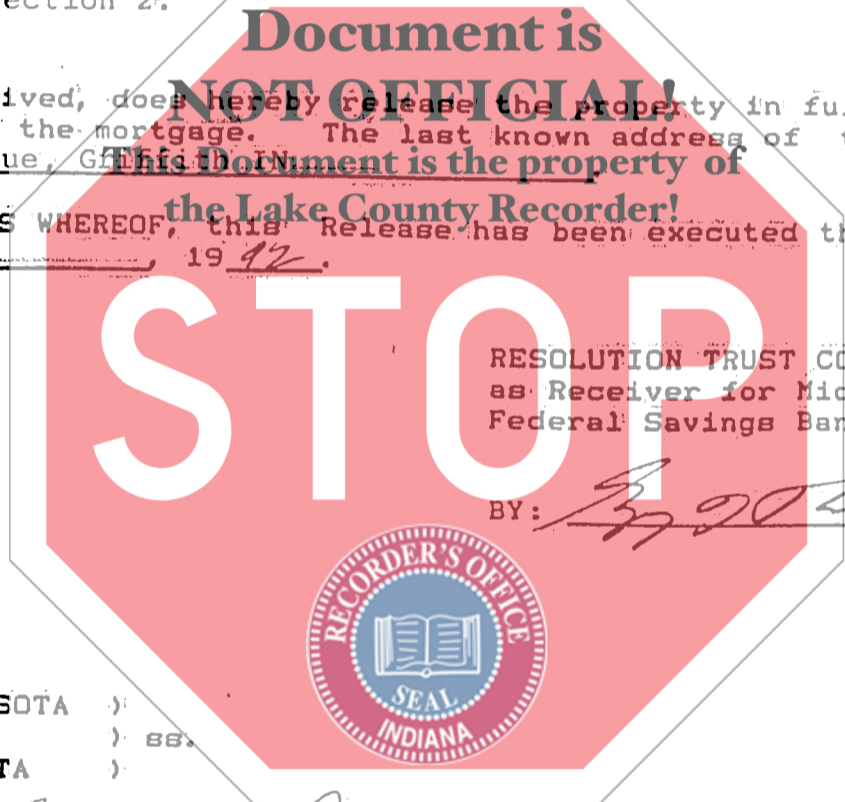
RELEASE OF MORTGAGE
