AFFIDAVIT OF HEIRSHIP

Geraldine T. Amalong, being duly sworn on oath, states that she is the widow of James H. Amalong, who died testate on April 3, 1989, survived by this affiant, and two children, Sandra Marion, and Michael Amalong, both adults, and by no other children or children of deceased children.

That the last will and testament of James H. Amalong was not spread of record after his death, and therefor he died intestate. Pursuant to the laws of intestacy of the State of Indiana, the decedent's assets would pass to his widow, this affiant, and to his children named above.

That at the time of the death of James H. Amalong, the sole asset owned in his name only was the following described real estate:

The South fifteen acres of the following real estate, to-wit: The Northeast Quarter (NE $\frac{1}{4}$) of the Southeast Quarter (SE $\frac{1}{4}$) of Section 19, Township 33 North, Range 9 West of the 2nd P.M. except therefrom that part described as: Commencing at the Northeast corner of said Northeast Quarter of the Southeast Quarter and running thence West 16 rods and 13 feet to the center of road, thence southeasterly along the center of road to a point on the South line of said Northeast Quarter of the Southeast Quarter (NE $\frac{1}{4}$) (SE $\frac{1}{4}$) which is 10 rods west of the Southeast corner of said Northeast Quarter (NE $\frac{1}{4}$) of the Southeast Quarter (SE $\frac{1}{4}$); thence East to said Southeast corner of the Northeast Quarter of the Southeast Quarter (NE $\frac{1}{4}$) (SE $\frac{1}{4}$) thence North to the place of beginning, in Lake County, Indiana, EXCEPT the North 80 feet of the above-described real estate. Said real estate is estimated to be worth approximately \$12,500.00. No Indiana inheritance tax or Federal Estate tax was due on decedent's estate. All debts and obligations of the decedent have been paid.
