# SATISFACTION OF MORTGAGE

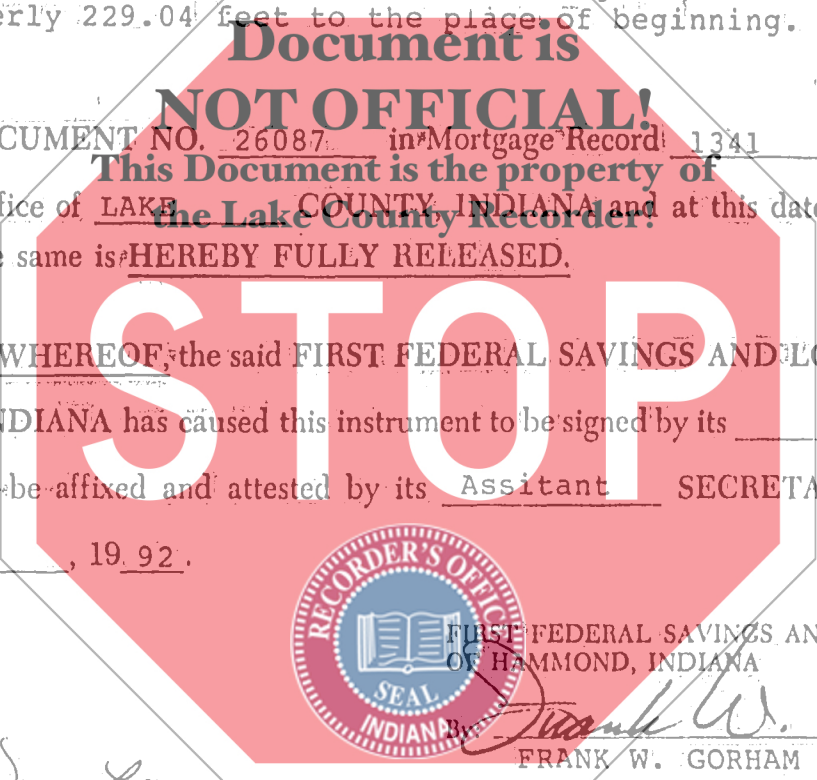


THIS CERTIFIES that a certain mortgage executed by ROBERT D. CAMPBELL and

A part of the West half of the Northeast quarter of the Northeast quarter of Section 30, Township 35 North, Range 9 West of the Second Principal Meridian in St. John Township, Lake County, Indiana, described as beginning at a point in the South line of said West half of said Northeast quarter of the Northeast quarter, which point is 164.97 feet Westerly of the Southeast corner of said West half of said Northeast quarter of the Northeast quarter measured along said South line; thence continuing Westerly on said South line, 222.88 feet; thence Northeasterly on a line that deflects 62 degrees, 17 minutes to the North from said South line, 250.96 feet to the arc of a 50 foot radius circle, the center of which is 50 feet from this arc on a projection of aforesaid 250.96 foot line; thence Southeasterly on said arc of 50 foot radius, convex to the South 39.27 feet to a point on said curve that has subtended a central angle of 45 degrees, thence Southeasterly 229.04 feet to the place of beginning.
