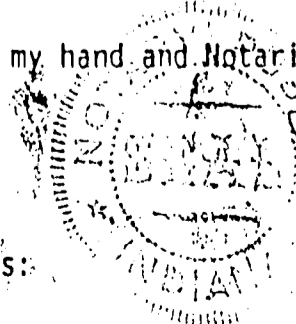

A parcel of land being part of the Southwest Quarter of Section 29, Township 34 North, Range 7 West of the 2nd P.M., in Winfield Township, Lake County, Indiana, described as follows: Beginning at the Northwest corner of said Southwest Quarter; thence East along the North line of said Southwest Quarter to a point 1585.5 feet West of the Northeast corner of said Southwest Quarter, said point being the Northwest corner of a parcel of land described in Document NO. 999285 in the Lake County Recorder's Office; thence South at 90 degrees to said North line, 341.65 feet; thence East parallel to said North line, 255.0 feet; thence North at 90 degrees to said North line, 341.65 feet to a point on said North line, 1330.5 feet West of the Northeast corner of said Southwest Quarter, said point being the Northeast corner of Parcel described in said Document NO. 999285; thence East along said North line, 450.1 feet to a point 880.4 feet West of the Northeast corner of said Southwest Quarter; said point being the Northwest corner of a Parcel of land described in Document NO. 321670 in the Recorder's Office of Lake County, Indiana; thence South at 90 degrees to said North line 560.0 feet to the Southwest corner of Parcel described in Document NO. 63809 in the Recorder's Office of Lake County, Indiana; thence Southeasterly at an angle of 116 degrees 40 minutes measured North to East from the last described line, 106 feet, more or less, to the centerline of the East Branch of the Stony Run Ditch; thence Northeasterly along said centerline to the North line of said Southwest Quarter, said point being 681.40 feet West of the Northeast corner of said Southwest Quarter; thence East along said North line, 472.69 feet to a point 208.71 feet West of the Northeast corner of said Southwest Quarter; said point being the Northwest corner of a Parcel of land described in Deed Record 1382, page 50, in the Recorder's Office of Lake County, Indiana; thence South parallel to the East line of said Southwest Quarter, 228.71 feet; thence East parallel to the North line of said Southwest Quarter, 208.71 feet to said East line, said point being the Southeast corner of said Parcel described in Deed Record 1382, page 50; thence South along said East line to the Southeast corner of said Southwest Quarter; thence West along the South line of said Southwest Quarter, to the Southeast corner of the Southwest Quarter of said Southwest Quarter; thence North along the East line of said Southwest Quarter Quarter to the Northeast corner of said Southwest Quarter Quarter; thence West along the North line of said Southwest Quarter Quarter to the Northwest corner of said Southwest Quarter Quarter, thence North along the West line of said Southwest Quarter to the Northwest corner of said Southwest Quarter, said point being the point of beginning.
