That the aforesaid decedent, John H. Luptak, deceased owned the following-described real estate at the time of his death, to-wit:

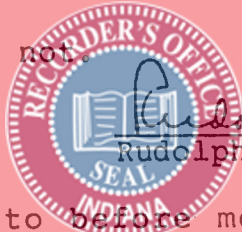
