WHEREAS, the said Principal has applied to said Obligor for a license to or permit as a Alarm Installation Contractor

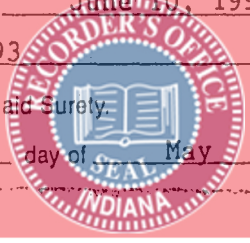

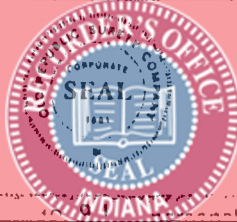

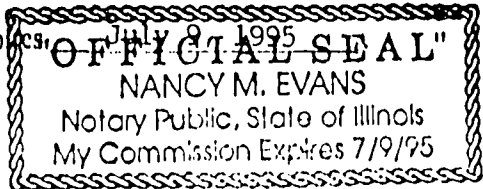
