the payment of one promissory note, of even date, in the amount of Thirteen Thousand Five Hundred Eleven
DOLLARS, (13,511.88), made and executed by the mortgagor, payable to the order of the mortgagee, in accordance & 88/100
with the terms as set out in said promissory note.

In the event of a proceeding to foreclose this mortgage, the mortgagor agrees to pay reasonable attorneys fees and such
other expenses necessarily a part of such proceeding.
