SUBORDINATION AGREEMENT

This Agreement made this 22 day of May, 1992, by and between SUBURBAN MORTGAGE CO., INC. (hereinafter referred to as "Suburban") and LAKE DALECARLIA REGIONAL WASTE DISTRICT (hereinafter referred to as "Dalecarlia").

WHEREAS, Dalecarlia has agreed to subordinate their rights and priorities to that of Suburban.

NDW, THEREFORE, in consideration of the mutual covenants and agreement therein a contained, the parties agree as follows:

- 1. In consideration of Calecarlia subordinating the lien held by it to the lien of Suburban as set forth here/on Suburban shall loan the sum of \$55,000.00 to Theodore A. Engels and Barbara L. Engels.
- 2. Dalecarlia hereby covenants, consents and agrees with Suburban that the lien held by Dalecarlia is and shall continue to be subject and subordinate in lien to the lien of the mortgage about to be made and recorded by Suburban as aforesaid and as recorded on DEC, 9, 99, as Document No. 9062766.
- 3. This Agreement shall inure to the benefit of the parties herein, their successors, heirs and assigns.
