MORTGAGOR: Elias Malave and Juanita Marie Malave, husband and wife.

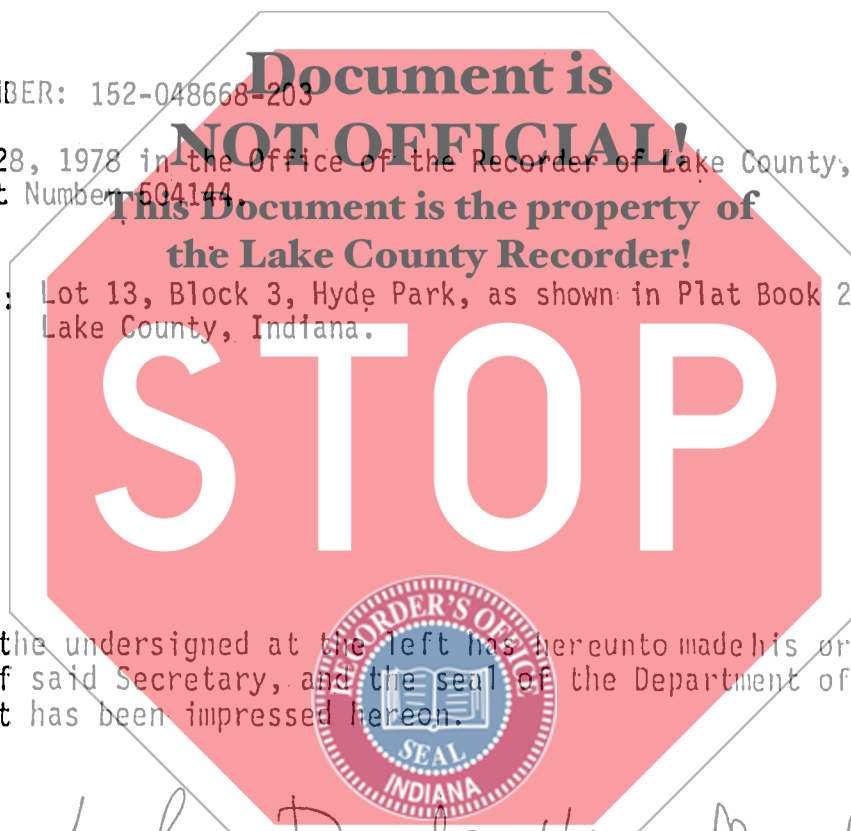
