

5. 1. Said Final Report and Account of said personal representative is hereby in all things approved, settled, and confirmed.
2. That the distribution of the balance of the property remaining in said personal representative's hands for distribution has been made pursuant to the distribution set forth in the final accounting to the decedent's heirs at law, and is hereby in all things approved.

3. That pursuant to the laws of intestacy, the following described real estate, to-wit:



Said personal representative has complied with the terms of this order and that said personal representative has in all things carried out the provisions of this final decree; and is hereby released and discharged from any further liability or responsibility along with her surety as said personal representative of the estate of Wilfred Butler.
