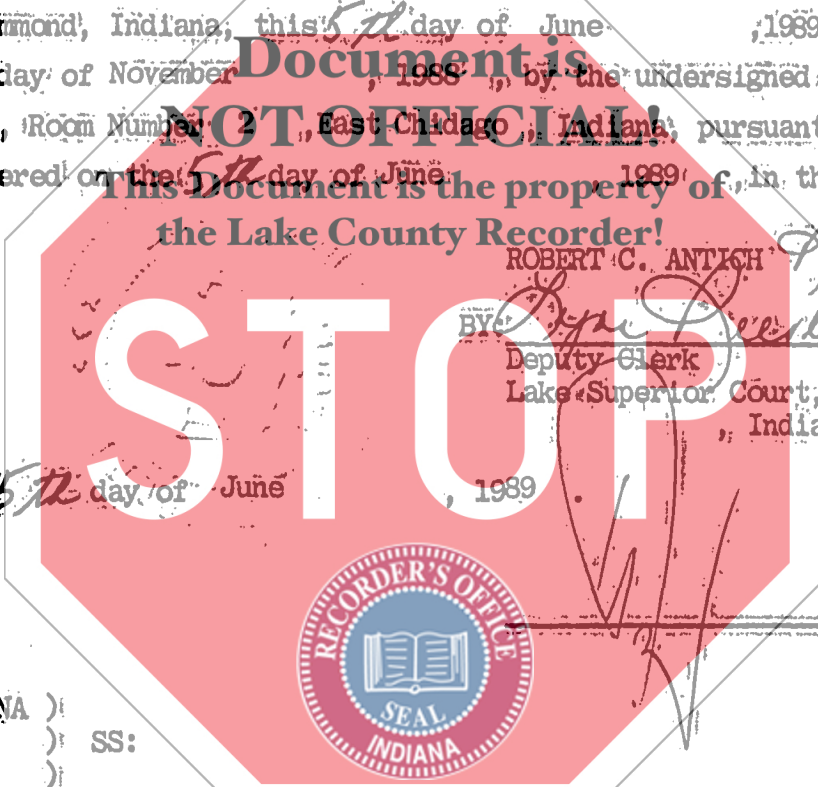

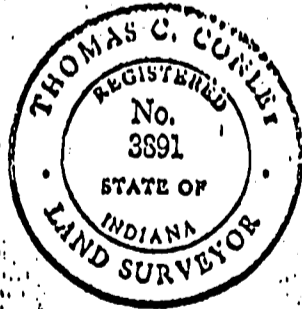

A part of Lot 1 in Kaufman's Industrial Addition to the City of Hammond, Indiana, the plat of which is recorded in Plat Book 19, page 7 in the Office of the Recorder of Lake County, Indiana, described as follows: Beginning at the northeast corner of Lot 1; thence South 0 degrees 22 minutes 30 seconds West 40.00 feet along the east line of said lot; thence North 49 degrees 49 minutes 10 seconds West 39.05 feet to a point 15.00 feet south of the north line (measured at right angles) of said lot; thence North 89 degrees 37 minutes 48 seconds West 90.00 feet along a line, which line is parallel with the north line of said lot to a point 50.00 feet east of the west line of said lot; thence North 0 degrees 22 minutes 30 seconds East 15.00 feet along a line which line is parallel with the west line of said lot to the north line of said lot; thence South 89 degrees 37 minutes 48 seconds East 120 feet along said north line to the point of beginning and containing 2,175 square feet more or less. All bearings in this description are based on the bearing system for State Highway Project HES-019-6(18).
