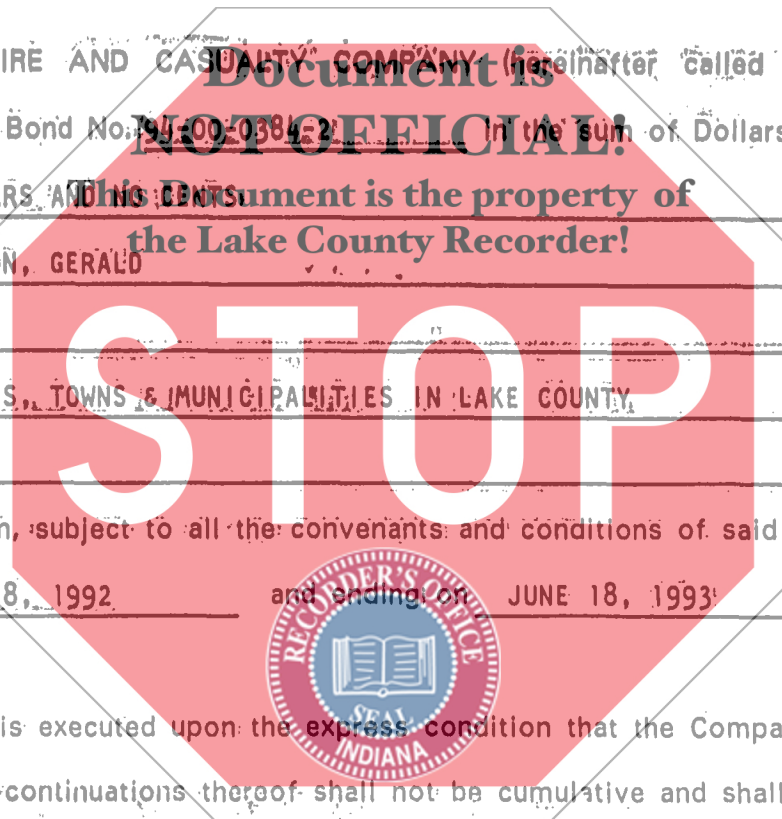

Any such power, as executed and sealed and certificate, so executed and sealed shall, with respect to any bond or undertaking to which it is attached, continue to be valid and binding on the Company.
