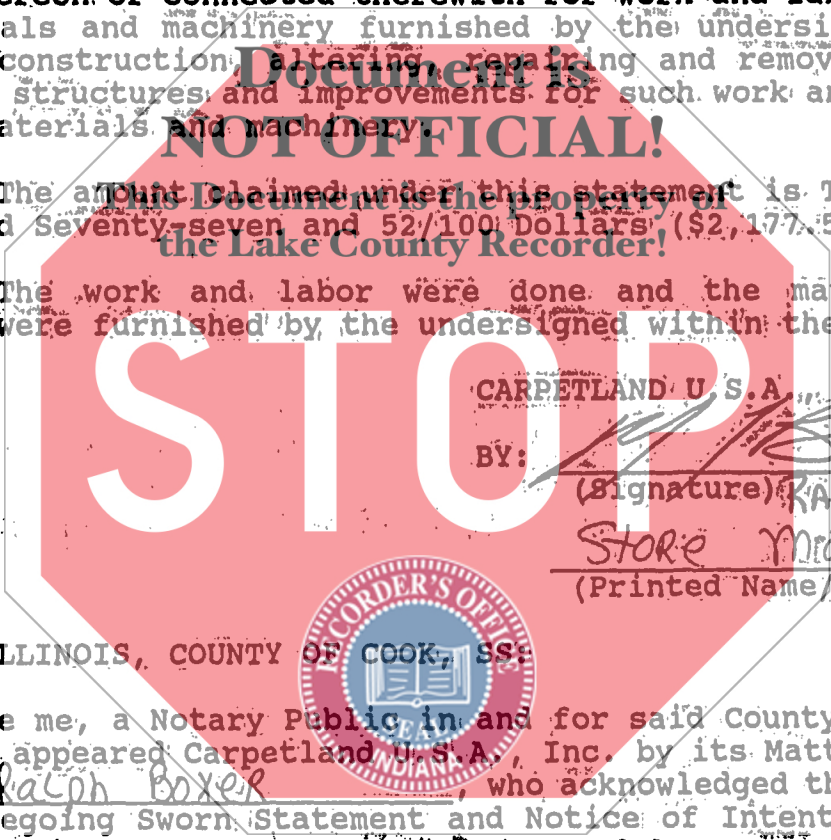
Lot 15, Southmoor Park, as shown in Plat Book 33, page 66, in Lake County, Indiana;
