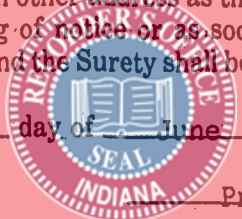

This bond may be terminated at any time by the Surety upon sending notice in writing to the Obligees and to the Principal, in care of the Obligees or at such other address as the Surety deems reasonable, and at the expiration of thirty-five (35) days from the mailing of notice or as soon thereafter as permitted by applicable law, whichever is later, this bond shall terminate and the Surety shall be relieved from any liability for any subsequent acts or omissions of the Principal.

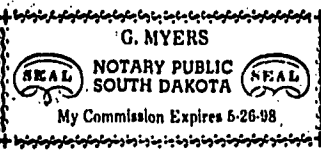

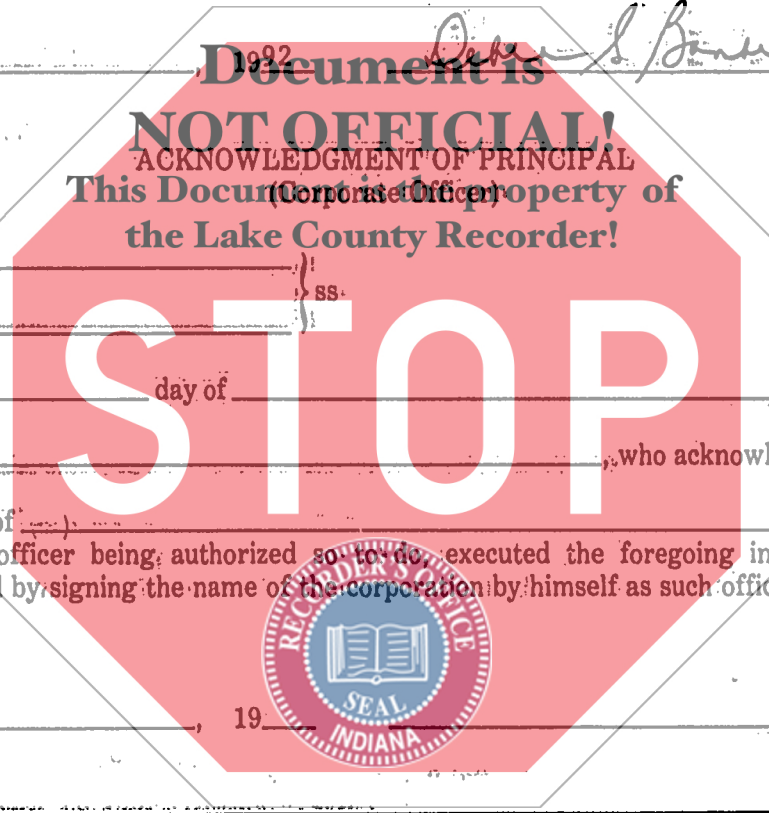
