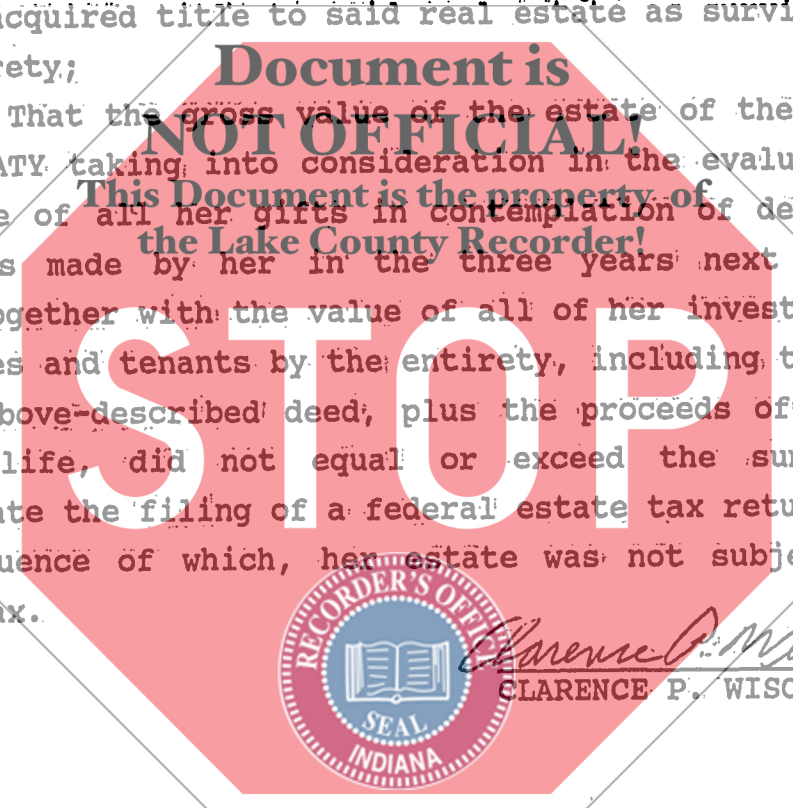
AFFIDAVIT OF SURVIVORSHIP

CLARENCE P. WISOWATY, being first duly sworn upon his oath, deposes and says:

1. That he and his now deceased wife, CLOTILDE E. WISOWATY were husband and wife at the time they acquired title, as tenants by the entirety, to certain real estate by deed recorded on the 30th day of November, 1955 as in Book 1016, at Page 49 in the office of the Recorder of Lake County, Indiana; **SEE ATTACHED FOR LEGAL DESCRIPTION**

2. That the marital relationship which existed between said affiant and CLOTILDE E. WISOWATY, his wife, continued unbroken from the time they so acquired title to said real estate until the death of his said wife in April of 1961, at which time this affiant acquired title to said real estate as surviving tenant by the entirety;

3. That the gross value of the estate of the said CLOTILDE E. WISOWATY taking into consideration in the evaluation thereof, the value of all her gifts in contemplation of death, including all gifts made by her in the three years next preceding her death, together with the value of all of her investments in joint properties and tenants by the entirety, including the real estate in the above-described deed, plus the proceeds of all insurance on her life, did not equal or exceed the sum required to necessitate the filing of a federal estate tax return and that as a consequence of which, her estate was not subject to federal estate tax.
