ASSIGNMENT OF MORTGAGE

On June 14, 1991, First Commerce Bank, formerly known as Mutual Savings and Loan Association and Mutual Federal Savings Bank, a Federal Savings Bank, was closed by the Office of Thrift Supervision ("OTS") pursuant to Section 5 (d) (2) (A) of the Home Owners Loan Act of 1933 ("HOLA"); as amended by Section 301 of the Financial Institutions Reform, Recovery and Enforcement Act of 1989 ("FIRREA");, OTS pursuant to order number 91-356, appointed the Resolution Trust Corporation ("RTC") as Receiver of First Commerce Bank, a Federal Savings Bank.

On June 14, 1991, the OTC by order number 91-356, chartered First Commerce Savings Bank, FSB, as a federal mutual savings bank, and pursuant to Section 3 (d) (2) (B) (1) of HOLA, appointed the RTC as Conservator for First Commerce Savings Bank, FSB.

On February 7, 1992, the OTS by order number CHI-92-06, appointed the RTC as the Receiver for First Commerce Savings Bank, FSB.

This Assignment made this 7th day of February, 1992, by and between THE RESOLUTION TRUST CORPORATION, as Receiver for First Commerce Savings Bank, FSB, ("Assignor"), and CENTIER BANK, ("Assignee").

Assignor hereby sells, assigns, transfers and sets over unto Assignee, all right, title and interest of Assignor in and to a certain mortgage executed by ROBERT BRANNON AND JOAN BRANNON, HUSBAND AND WIFE, to FIRST COMMERCE BANK, A FEDERAL SAVINGS BANK, dated March 27, 1990, in the amount of Twenty-three thousand seven hundred and sixty-eight & 62/100 dollars (\$ 23,078.62), together with the note secured thereby, said mortgage having been recorded in Mortgage Record 094480, on page _____, in the Recorder's office of Lake County, Indiana on April 10, 1990.

Assignee hereby accepts the foregoing assignment and does hereby assume and become responsible for all of the Assignor's obligations under said Mortgages arising after the date hereof.

This Assignment shall be binding upon, and inure to the benefit of Assignor, Assignee and their respective legal representative, heirs, successors and assigns.

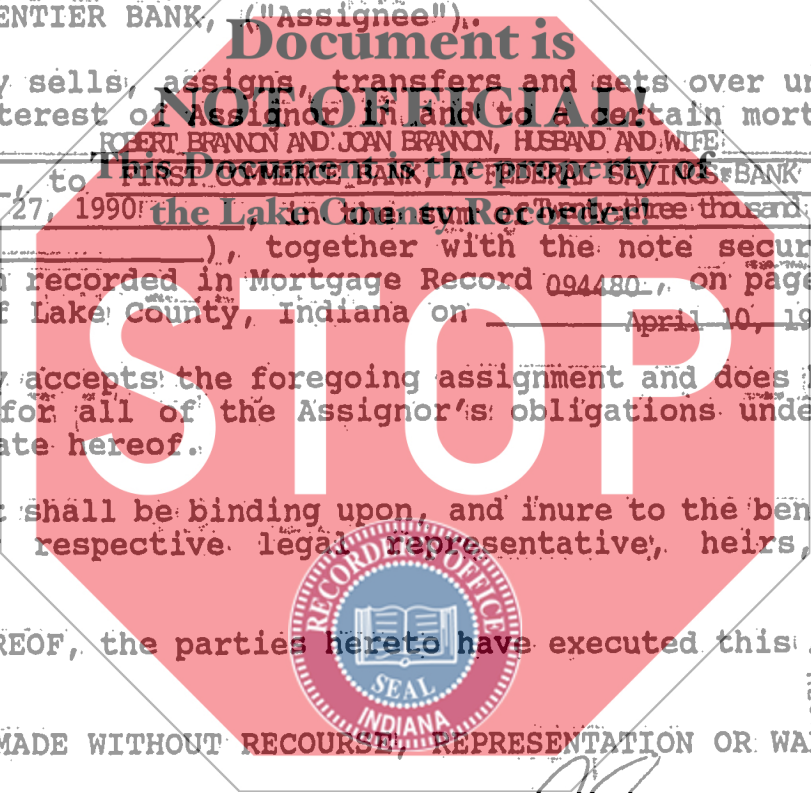
