ASSIGNMENT AND SATISFACTION OF MORTGAGE

The RESOLUTION TRUST CORPORATION was appointed Receiver of United Federal Savings Bank, Windom, Minnesota on May 10, 1990 by order number 90-788 of the Office of Thrift Supervision pursuant to Section 5(d)(2) of the Home Owners' Loan Act of 1933, as amended by Section 301 of the Financial Institutions Reform, Recovery and Enforcement Act of 1989, 12 U.S.C. Section 1464(d)(2) (1989).

The RESOLUTION TRUST CORPORATION was appointed Receiver of United Savings Bank, F.S.B., Windom, Minnesota on July 6, 1990 by Order No. 90-1360 of the Office of Thrift Supervision pursuant to Section 5(d)(2) of the Home Owners' Loan Act, as amended by Section 301 of the Financial Institutions Reform, Recovery and Enforcement Act of 1989, 12 U.S.C. Section 1464(d)(2)(1989). On that date, the Receiver for United Federal Savings Bank, Windom, Minnesota transferred the below described Mortgage to United Savings Bank, F.S.B.; and for purposes of confirming said transfer, United Federal Savings Bank, Windom, Minnesota does hereby grant, sell, assign, transfer, set over and convey to United Savings Bank, F.S.B., its successors and assigns, without recourse or warranty, any interest United Federal Savings Bank, Windom, Minnesota may have in the below described Mortgage together with the note, debt and claim secured by the Mortgage and the covenants contained in the said Mortgage.



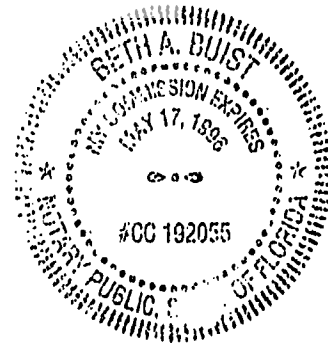
