NOW THEREFORE, IT IS ORDERED AND DECREED by the Court as follows:

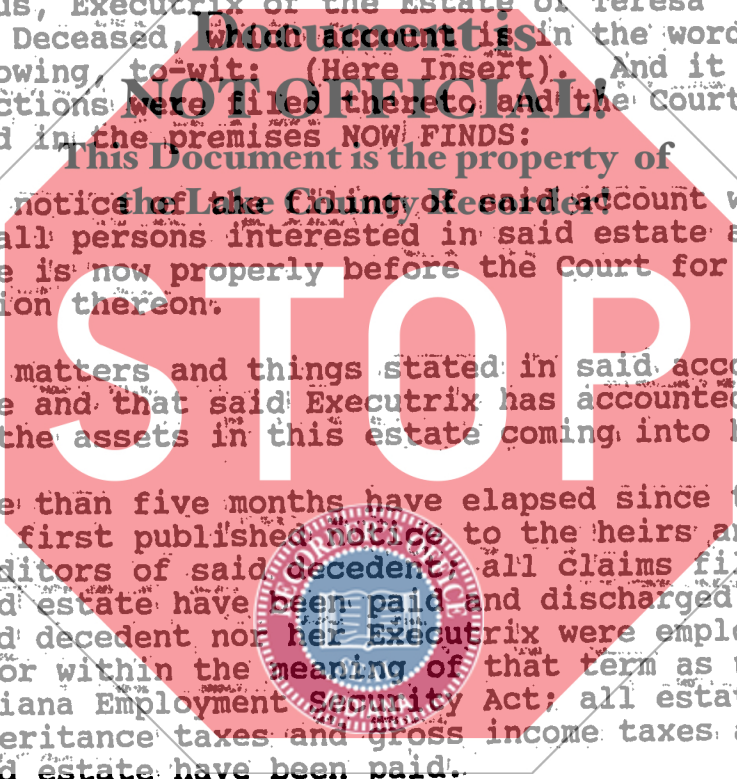
1. Said report and account of said Executrix is hereby in all things approved, settled and confirmed.

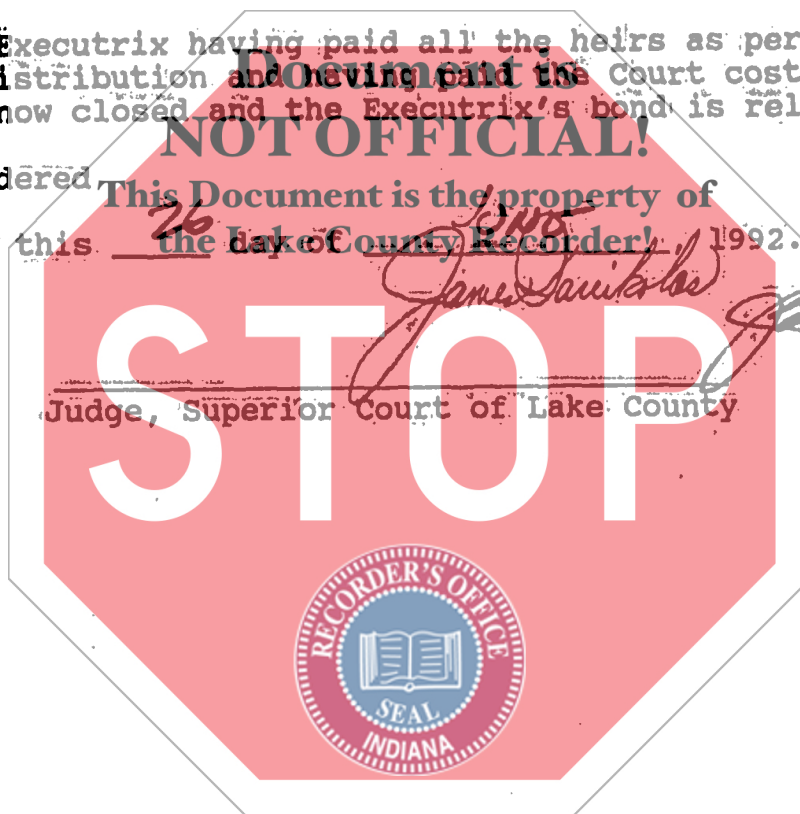

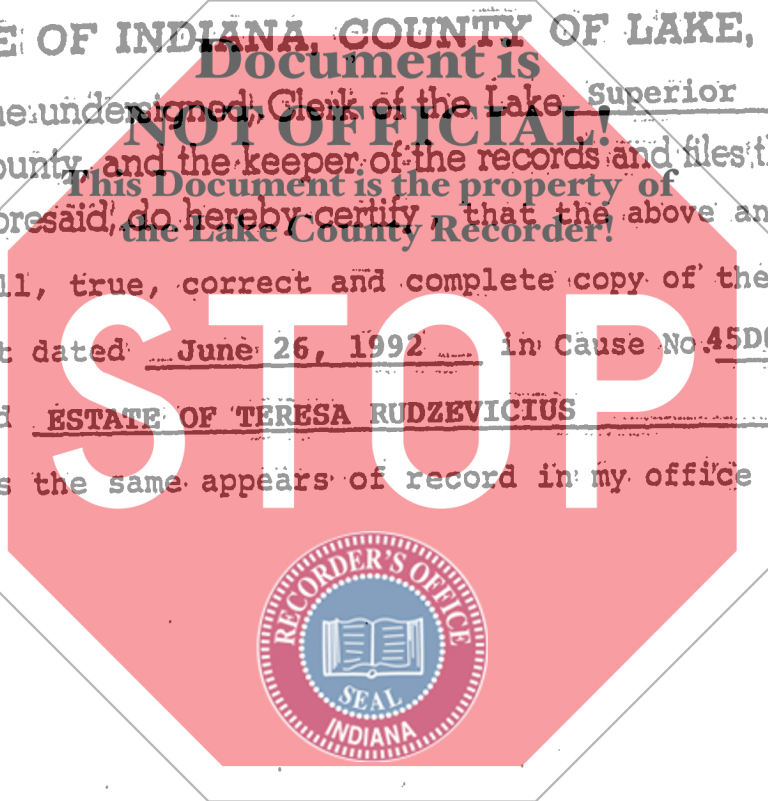
