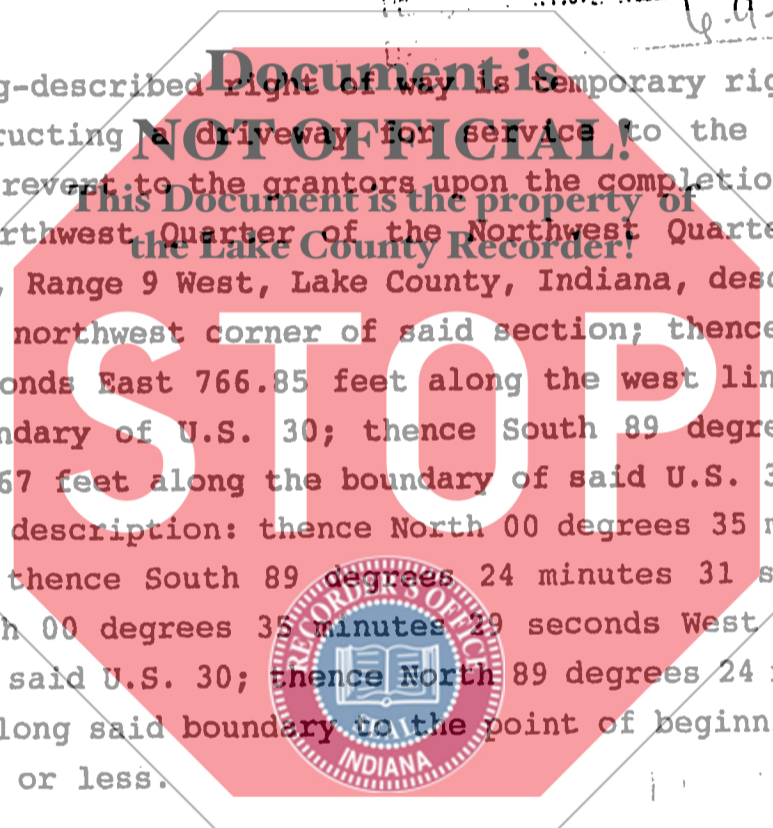

The following-described right of way is temporary right of way for the purpose of constructing a driveway for service to the grantors' private property and will revert to the grantors upon the completion of said project: A part of the Northwest Quarter of the Northwest Quarter of Section 17, Township 35 North, Range 9 West, Lake County, Indiana, described as follows: Commencing at the northwest corner of said section; thence South 03 degrees 43 minutes 30 seconds East 766.85 feet along the west line of said section to the north boundary of U.S. 30; thence South 89 degrees 24 minutes 31 seconds East 363.67 feet along the boundary of said U.S. 30 to the point of beginning of this description; thence North 00 degrees 35 minutes 29 seconds East 10.00 feet; thence South 89 degrees 24 minutes 31 seconds East 45.00 feet; thence South 00 degrees 35 minutes 29 seconds West 10.00 feet to the north boundary of said U.S. 30; thence North 89 degrees 24 minutes 31 seconds West 45.00 feet along said boundary to the point of beginning and containing 0.010 acres, more or less.
