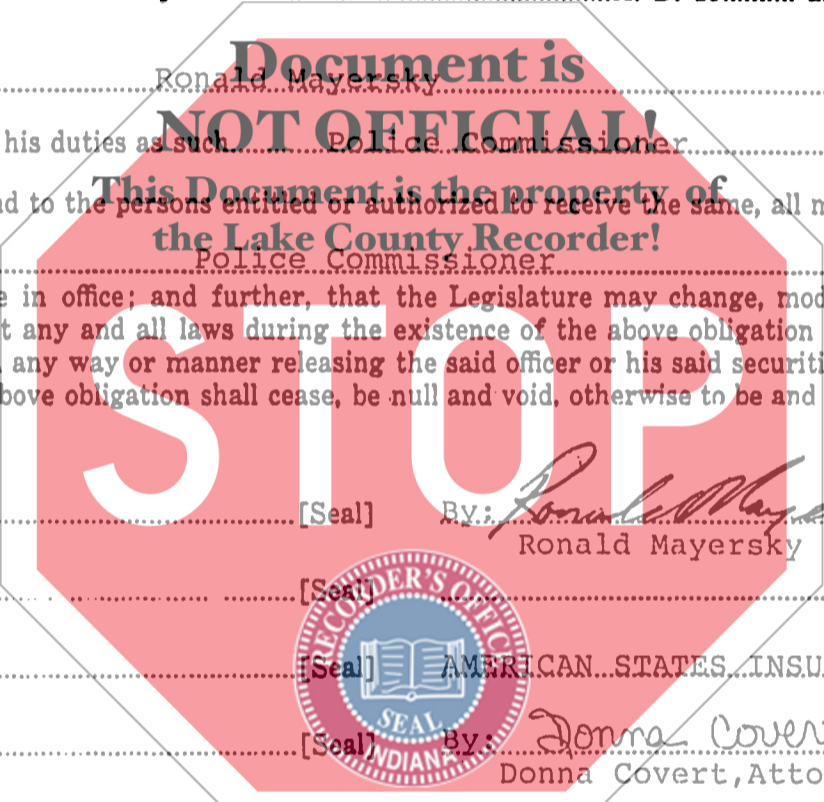


KNOW ALL MEN BY THESE PRESENTS, That we,
