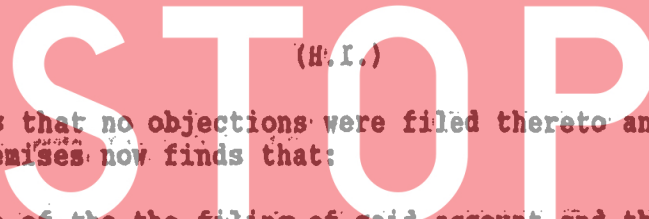

8. That all expenses of Administration of this Estate including Attorney fees to Richard A. Parks have been paid.

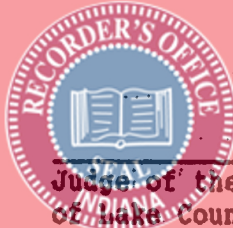
IT IS THEREFORE ORDERED, ADJUDGED AND DECREED, by the Court as follows
