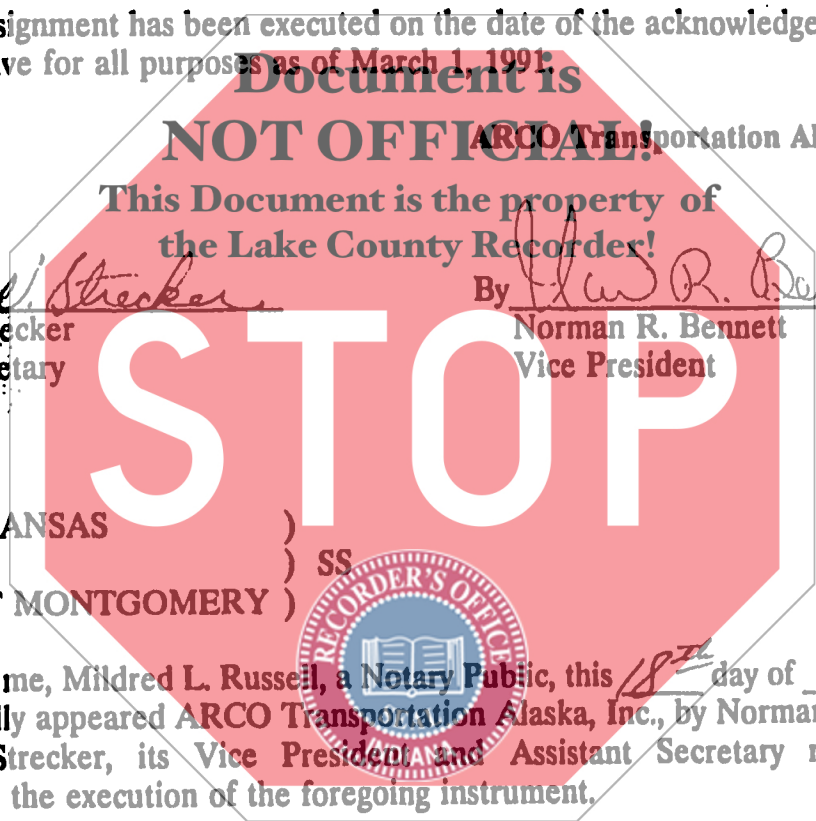
The Assignment has been executed on the date of the acknowledgement hereto but shall be effective for all purposes as of March 1, 1991.

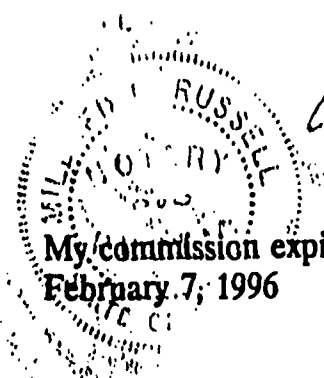
