A part of Lot 29, Union Addition to the Town of Lowell, as shown in Miscellaneous Record "A", page 504, in Lake County, Indiana, described as commencing at a point on the South line thereof which is 117.30 feet West of the Southeast corner of said lot which point is also the Southwest corner of a parcel of land conveyed by the Trustees of the Trinity Lutheran Church of the Missouri Synod, in charge of Lowell, Indiana property, to Indiana District Assemblies of God, Inc., by Warranty Deed dated May 22, 1950 and recorded June 19, 1950 in Deed Record 864, page 296, in the Recorder's Office of Lake County, Indiana, thence Northerly along the West line of said parcel 121.50 feet to the Northwest corner of said parcel, thence continuing Northerly in a straight line to a point in the South line of the North 4 rods of said Lot 29, which point is 119.20 feet West of the East line of said lot measured along the South line of the North 4 rods of said Lot 29, thence West along the South line of said North 4 rods, 50.28 feet to a point in the West line of said Lot 29, which marks the Southwest corner of the North 4 rods of said Lot 29, thence South along the West line of said Lot 29 a distance of 181.50 feet to the Southwest corner of said lot, thence East along the South line of said Lot 29 a distance of 53.20 feet to the place of beginning.
