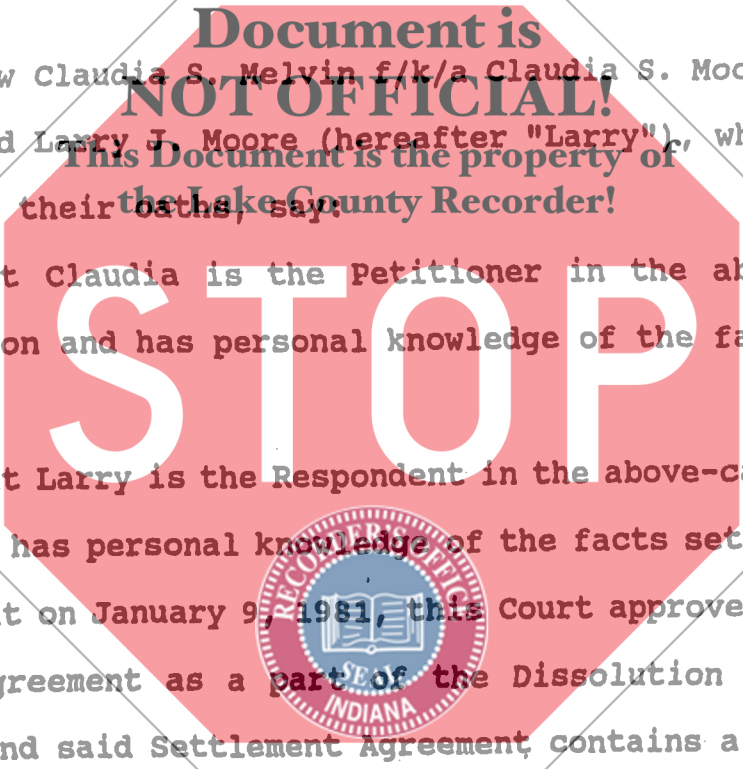
SATISFACTION OF JUDGMENT

1. That Claudia is the Petitioner in the above-captioned cause of action and has personal knowledge of the facts set forth herein.
2. That Larry is the Respondent in the above-captioned cause of action and has personal knowledge of the facts set forth herein.
3. That on January 9, 1981, this Court approved the parties' Settlement Agreement as a part of the Dissolution Decree in the above cause and said Settlement Agreement contains a judgment that provides in pertinent part as follows:

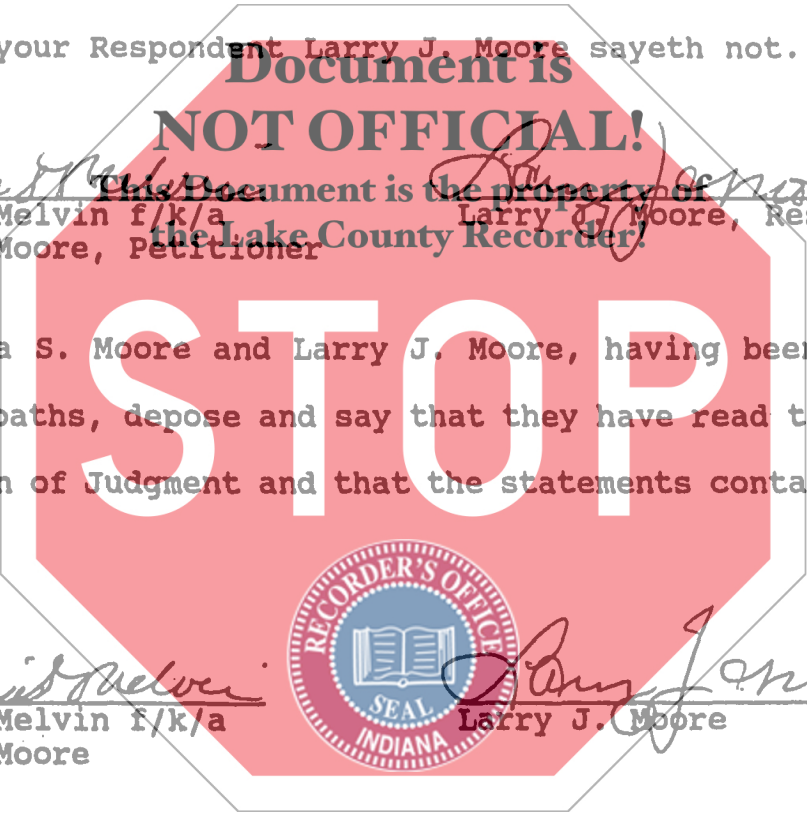
