MORTGAGE

This Mortgage made as of the 10 day of August, 1992, by and between the City of Hammond, acting by and through the Hammond Redevelopment Commission, and Lewis G. Carver, individually, d/b/a Carver's Sportswear & Accessories, Limited, (if more than one party jointly and severally hereinafter called "Mortgagor"), residing at Lake County, Indiana and the City of Hammond, Indiana (hereinafter called "Mortgagee"), acting by and through the Hammond Redevelopment Commission having an office at 649 Conkey Street, Hammond, Indiana,

WITNESSETH, that to secure the payment of and indebtedness in the principal amount of THIRTEEN THOUSAND (\$13,000.00) Dollars, with interest thereon, which shall be payable in accordance with a certain note bearing even date herewith, a true and correct copy of which, exclusive of the signature of the Mortgagor, is marked "Exhibit A" and is annexed hereto and made a part hereof, and to further secure all other cindebtedness which the Mortgagor, jointly and severally, is obligated to pay to the Mortgagee, including that evidenced by attached "Exhibit A" any advances or payments made by Mortgagee under the provisions of said Note or this Mortgage; any other indebtedness of any nature at any time incurred or owed by Mortgagor, either jointly or severally, to Mortgagee, including any Contingency Fund Loan hereafter granted by Mortgagee to Mortgagor pursuant to an "Agreement for Establishment of Contingency Fund" and any note evidencing the terms of such loan; any expenses, costs or attorneys' fees incurred by Mortgagee in connection with collection of any indebtedness owed it by Mortgagor; and any extensions or renewals of any obligation heretofore described, the Mortgagor hereby mortgages and warrants to the Mortgagee the following described property situate in Hammond, Lake County, Indiana:

The East 28 feet of Lot 36, Block 1, Townsend and Godfrey's Addition to the City of Hammond, as per plat thereof, recorded in Plat Book 150 page 40, in Office of the Recorder of Lake 7 County, Indiana.

TOGETHER, with all appurtenances thereto and all the estate and rights of the Mortgagor in and to such property or in anywise appertaining thereto; all buildings and other structures now or hereafter thereon erected or installed, and all fixtures and articles of personal property now or hereafter attached to, or used in, or in the operations of, any such land, buildings or structures which are necessary to the complete use and occupancy of such buildings or structures for the purpose for which they were or are to be erected or installed, including, but not limited to all heating, plumbing, bathroom, lighting, cooking, laundry,

ventilating, refrigerating, incinerating, and air-conditioning equipment and fixtures and all replacements thereof and additions thereto, whether or not the same are or shall be attached to such land, buildings or structures in any manner;

TOGETHER, with any and all awards now or hereafter made for the taking of the property mortgaged hereby, or any part thereof (including any easement), by the exercise of the power of eminent domain, including any award for change of grade of any street or other roadway, which awards are hereby assigned to the Mortgagee and are deemed a part of the property mortgaged hereby, and the Mortgagee is hereby authorized to collect and receive the proceeds of such awards, to give proper receipts and acquittances therefor, and to apply the same toward the payment of the indebtedness secured by this Mortgage, notwithstanding the fact that the amount owing thereon may not then be due and payable; and the Mortgagor hereby agrees, upon request, to make, execute and deliver any and all assignments and other instruments sufficient for the purpose of assigning each such award to the Mortgagee free, clear and discharged of any encumbrances of any kind or nature whatsoever; and

in and to the land lying in the streets and roads in front of and adjoining the above described land (all the above described land, buildings, other structures, fixtures, articles of personal property, awards and other rights and interests being hereinafter called the "mortgaged property").

TO HAVE AND TO HOLD the mortgaged property and every part thereof unto the Mortgagee, its successors and assigns forever for the purposes and uses herein set forth.

AND the Mortgagor further covenants and agrees with the Mortgagee, as follows:

- 1. The Mortgagor will promptly pay the principal of and interest of the indebtedness evidenced by the Note, and all other charges and indebtedness provided therein and in this Mortgage, at the times and in the manner provided in the Note and in this Mortgage.
- 2. The Mortgagor will pay when due, as hereinafter provided, all ground rents, if any, and all taxes, assessments, water rates and other governmental charges, fines and impositions, of every kind and nature whatsoever, now or hereafter imposed on the mortgaged property, or any part thereof, and will pay when due every amount of indebtedness secured by any lien to which the lien of this mortgage is expressly subject.

- This Mortgage and the Note were executed and delivered to secure moneys advanced, or to be advanced, by the Mortgagee as or on account of a loan evidenced by the Note, for the purpose of making the improvements described or referred to in the Business Development Loan Agreement dated ___ to or on the mortgaged property, and for such other purpose, if any, described or referred to therein, which improvements are hereafter collectively called "Improvements". The Mortgagor shall make or cause to be made all the Improvements. If the construction or installation of the Improvements shall not be carried out with reasonable diligence, or shall be discontinued at any time for any reason, other than strikes, lockouts, acts of God, fires, floods or other similar catastrophes, riots, war or insurrection, the Mortgagee after due notice to the Mortgagor is hereby authorized (a) to enter upon the mortgaged property and employ any watchmen to protect the Improvements from depredation or injury and to preserve and protect such property, (b) to carry out any or all then existing contracts between the Mortgagor and other parties for the purpose of making any of the Improvements. (c) to make and enter into additional contracts and incur obligations for the purposes of completing the improvements pursuant to the obligations of the Mortgagor hereunder, either in the name of the Mortgagee or the Mortgagor, and (d) toppagand duscharge aldedebts, obligations and liabilities incurred by reason of any action taken by the Mortgagee, as provided in this Paragraph, all of which amounts so paid by the Mortgagee shall be payable by the Mortgagor to the Mortgagee on demand and shall be secured by this Mortgage; provided, however, that the Mortgagee shall not be required to perform any act so authorized.
- 4. In the event Mortgagor shall fail to cause payments to be delivered when they shall be due, meaning actual receipt of the City, a processing charge equal to five (5%) percent of the payment then due shall be added to the payment due, provided that the payment shall be made within ten (10) days of the due date. In the event the payment is not made within the ten (10) day period, then the entire unpaid principal balance due upon said loan, together with interest accrued to said date of the due and unpaid payment, shall bear interest at the rate of eighteen (18%) percent until payments due shall be brought current.
- 5. No building or other structure or improvement, fixture or personal property mortgaged hereby shall be removed or demolished without the prior written consent of the Mortgagee. The Mortgagor will not make, permit or suffer any alteration of or addition to any building or other structure or improvement now or which may hereafter be erected or installed upon the mortgaged property, or any part thereof, except the improvements required to be made pursuant to Paragraph 3 hereof, nor will the Mortgagor use, or permit or suffer the use of, any of the mortgaged property for any purpose other than the purpose or purposes for which the same is now intended to be used, without the prior written consent of the

Mortgagee. The Mortgagor will maintain the mortgaged property in good condition and state of repair and will not suffer or permit any waste to any part thereof, and will promptly comply with all the requirements of Federal, state and local governments, or of any departments, divisions or bureaus thereof, pertaining to such property or any part thereof.

- 6. The Mortgagor will not voluntarily create, or permit or suffer to be created or to exist, on or against the mortgaged property, or any part thereof, any lien superior to the lien of this Mortgage, exclusive of the lien or liens, if any, to which the Mortgage is expressly subject, as set forth in the granting clause above, and will keep and maintain the same free from the claims of all parties supplying labor or materials which will enter into the construction or installation of the improvements.
- 7. (a) The Mortgagor will keep all buildings, other structures and improvements, including equipment, now existing or which may hereafter be erected or installed on the land mortgaged hereby, insured against loss by fire and other hazards, casualties and contingencies in such amounts and manner, and for such periods, all as may be required from time to time by the Mortgagee. Unless otherwise required by the years all such insurance shall be effected by Standard Fire and Extended Coverage Insurance policies, in amounts not less than necessary to comply with the coinsurance clause percentage of the value applicable to the location and character of the property to be covered. All such insurance shall be carried in companies approved by the Mortgagee and all policies therefor shall be in such form and shall have attached thereto loss payable clauses in favor of the Mortgagee and any other parties as shall be satisfactory to the Mortgagee. such policies and attachments thereto shall be delivered promptly to the Mortgagee, unless they are required to be delivered to the holder of a lien of a mortgage or similar instrument to which this Mortgage is expressly subject in which latter event certificates thereof, satisfactory to the Mortgagee, shall be delivered promptly to the Mortgagee. The Mortgagor will pay promptly when due, as hereinafter provided, and any and all premiums on such insurance, and in every case in which payment thereof is not made from the deposits therefor required by this Mortgage, promptly submit to the Mortgagee for examination receipts or other evidence of such payment as shall be satisfactory to the Mortgagee. The Mortgagee may obtain and pay the premium on (but shall be under no obligation to do so) every kind of insurance required hereby if the amount of such premium has not been deposited as required by this Mortgage, in which event the Mortgagor will pay to the Mortgagee every premium so paid by the Mortgagee.
- (b) In the event of loss or damage to the mortgaged property, the Mortgagor will give to the Mortgagee immediate notice thereof by mail, and the Mortgagee may make and file proof of loss if not made otherwise promptly by or on behalf of the Mortgagor.

Each insurance company issuing any such policy is hereby authorized and directed to make payment hereunder for such loss directly to the Mortgagee, instead of to the Mortgagor and the Mortgagee jointly, unless the amount of loss is payable first to the holder of a lien under a mortgage or similar instrument to which this Mortgage is expressly subject; and the insurance proceeds or any part thereof is received by the Mortgagee may be applied by the Mortgagee, at its option, either in reduction of the indebtedness hereby secured, or to the restoration or repair of the mortgaged property damaged. In the event of foreclosure of this Mortgage, or transfer of title to the mortgaged property of extinguishment of such indebtedness, all right, title and interest of the Mortgagor in and to every such insurance policy then in force, subject to the rights and interests of the holder of any such prior lien, shall pass to the grantee acquiring title to the mortgaged property together with such policy and appropriate assignment of such right title and interest which shall be made by the Mortgagor. the Mortgagor.

- 8. The Improvements and Fall Islans and specifications therefor shall comply with all applicable municipal ordinances, regulations, and rules made or promulgated by lawful authority, and upon their completion shall comply therewith.
- 9. Upon any failure by the Mortgagor to comply with or perform any of the terms, covenants or conditions of this Mortgage requiring the payment of any amount of money by the Mortgagor, other than the principal amount of the loan evidenced by the Note, interest and other charges, as provided in the Note, the Mortgagee may at its option make such payment. Every payment so made by the Mortgagee (including reasonable attorney's fees incurred thereby), with interest thereon from the date of such payment, at the rate of eighteen (18%) percent per annual except any payment for which a different rate of interest is specified herein, shall be payable by the Mortgagor to the Mortgage on demand and shall be secured by this Mortgage. This Mortgage with respect to any such amount and the interest thereon, shall constitute a lien on the mortgaged property prior to any other lien attaching or accruing subsequent to the lien of this Mortgage.
- 10. The Mortgagee, by any of its agents or representatives, shall have the right to inspect the mortgaged property from time to time at any reasonable hour of the day. Should the mortgaged property, or any part thereof, at any time require inspection, repair, care or attention of any kind or nature not provided by this Mortgage as determined by the Mortgage in its sole discretion, the Mortgagee may, after notice to the Mortgagor, enter or cause entry to be made upon, the mortgaged property, and inspect, repair, protect, care for or maintain such property, as the Mortgagee may in its sole discretion deem necessary, and may pay all amounts of money therefor, as the Mortgagee may in its sole discretion deem necessary.

- 11. The principal amount owing on the Note together with interest thereon and all other charges, as therein provided, and all other amounts of money owing by the Mortgagor to the Mortgagee pursuant to and secured or intended to be secured by this Mortgage, shall immediately become due and payable without notice or demand upon the appointment of a receiver or liquidator, whether voluntary or involuntary, for the Mortgagor or any of the property of the Mortgagor, or upon the filing of a petition by or against the Mortgagor under the provisions of any State insolvency law, or under the provisions of any Federal Bankruptcy Act or Code, as amended, or upon the making by the Mortgagor of an assignment for the benefit of the Mortgagor's creditors. The Mortgagee is authorized to declare, at its option, all or any part of such indebtedness immediately due and payable upon the happening of any of the following events:
- (a) Failure to pay the amount of any payment, or other charges payable on the Note, or the occurrence of any circumstance by which the entire remaining balance of the Note by its terms is immediately due and payable.
- This Document is the property of (b) Nonperformance by the Mortgagor of any covenant, agreement, term or condition of this chortgage, or of the Note (except as otherwise provided in subdivision (a) hereof) or of any other agreement heretofore, herewith or hereafter made by the Mortgagor with the Mortgagee in connection with such indebtedness;
- (c) Failure of the Mortgagor to perform any covenant, agreement, term of condition in any instrument creating a lien upon the mortgaged property, or any part thereof, which shall have priority over the lien of this Mortgage;
- (d) The Mortgagee's discovery of the Mortgagor's failure in any application of the Mortgagor to the Mortgagee to disclose any fact deemed by the Mortgagee to be material, or of the making therein or in any of the agreements entered into by the Mortgagor with the Mortgagee (including, but not limited to, the Note and this Mortgage) of any misrepresentation by, on behalf of, or for the benefit of, the Mortgagor;
- (e) The sale, lease, assignment or other transfer of any kind or nature of the mortgaged property, or any part thereof, without the prior written consent of the Mortgagee;
- (f) The enactment after the date of this Mortgage of any law of the State of Indiana deducting from the value of the mortgaged property (or any part thereof), for the purpose of taxation, any lien thereon, or changing in any way its laws for the taxation of mortgages or debts secured by mortgage for state or local purposes, or the manner of collection of any such tax, so as to affect this Mortgage, and if after such enactment or change the holder of the Note and this Mortgage gives written cause of any

such enactment or change, immediately upon the expiration of thirty (30) days after such notice.

(g) Impairment or deterioration of the mortgaged premises or any improvement thereon, or waste committed or permitted by the Mortgagor in regard to the mortgaged premises or any improvement thereon.

The Mortgagee's failure to exercise any of its rights hereunder shall not constitute a waiver thereof. All the events in this Paragraph numerated upon the happening of any of which the Note shall become, or may be declared to be, immediately due and payable, are in this Mortgage called "events of default".

- 12. The occurrence and continuation of any of the following events shall further constitute an "event of default" hereunder:
- (a) The lies and security interest in the property created by the Mortgage or financing statement shall for any reason cease to be in full force and effect, valid and perfected, subordinate only to remitted Encumbrances; or
- This Document is the property of the Owner shall default in the payment of any obligations for bortowed Money of Yole the deferred purchase price of property or any rental obligation under any lease required to be capitalized in accordance with generally accepted accounting principles, or shall default in the performance of any obligation in connection therewith and the result thereof shall be to accelerate or permit the holder thereof (or a trustee on such holder's behalf) to accelerate the payment of such obligations or capitalized lease obligation; or
- its debts as they mature, to shall file a voluntary petition seeking reorganization or to effect a plan or other arrangement with creditors or shall file an answer admitting the jurisdiction of the court and the material allegations of an involuntary petition, pursuant to any act relating to bankruptcy or to any act purporting to be amendatory thereof, or shall be adjudicated bankrupt or insolvent, or shall make an assignment for the benefit of creditors or to an agent authorized to liquidate any substantial amount of its assets, or shall apply for or consent to or suffer the appointment of any receiver or trustee for it or a substantial part of its property or assets; or
- (d) A proceeding shall be instituted, without the application, approval or consent of the Owner, pursuant to any act relating to bankrupt or to any act purporting to be amendatory thereof, seeking:
 - (i) adjudication of the Owner as bankrupt or insolvent;

- (ii) reorganization of, or an order appointing any receiver or trustee for, the Owner or any receiver or trustee of a substantial part of the property or assets of the Owner; or
- (iii) issuance of a writ of attachment or any similar process against a substantial part of the property or assets of the Owner; or
- (i) Any "Event of Default" then, and in any such event, the City may, in its sole discretion, but shall not be obligated to,
 - by notice to the Owner, declare the Obligations and all other obligations of the Owner hereunder to be forthwith due land payable, and the same shall thereupon become due and payable without presentment demand protest or further notice of any kind, all of which are This Dochereby is present payable.
 - (ii) the Lake Such yor her action under the Mortgage as shall be permitted thereby;
 - (iii) take such other action as is permitted by law.

Upon the occurrence of any Event of Default:

(A) the City personally or by its agents or attorneys, may, to the extent permitted by law, enter into and upon all or any part of the property and each and every part thereof, and may exclude the owner, its agents and servants wholly therefrom; and having and holding the same, may use, operate, manage and control the property for any lawful purpose, and upon every such entry, the City, at the expense of the Owner cither by purchase, repairs, or construction, may from time to wime maintain and restore the property whereof it shall become possessed as aforesaid, and may insure and reinsure the same as may seem to it to be judicious and likewise, from time to time at the expense of the Owner, the City may make all necessary or proper repairs, renewals, alterations, additions, betterments replacements, and improvements thereto and thereon as to it may seem judicious; and the City shall be entitled to collect and receive all earnings, revenues, rents, issues, profits and income of the same and every part thereof; and after deducting the expenses of operations, maintenance, repairs, renewals, replacements, alterations, additions, betterments and improvements and all payments which may be made for taxes, assessments, insurance and prior or other proper charges upon the property or any part thereof, as well as all advances by the City and compensation for the services of the City and for all counsel and agents and clerks and other employees by it

properly engaged and employed, the City shall apply the moneys arising as aforesaid first to the payment of the Obligations and then to the remedying of any other event of default then existing:

- (B) the City, with or without entry, personally or by attorney, may in its discretion, proceed to protect and enforce its rights by suit or suits in equity or at law, whether for damages or for the specific performance of any covenant or agreement contained in the Mortgage or in aid of the execution of any power herein granted, or for any foreclosure hereunder, or for the enforcement of any other appropriate legal or equitable remedy, as the City shall deem most effectual to protect and enforce any of its rights or duties hereunder; provided, however, that all costs incurred by the City under this Article shall be paid to the City by the Owner on demand; and
- (C) the City, in its discretion may, with or without entry, personally or by attorney, sell, to the extent permitted by law, to the highest bidder all or any part of the property and all right, title, interest, claim on demand therein, and the right of redemption thereof, in one lot as an entirety, or in separate lots, as the City may elect and in one sale or in any number of separate sales held at one time or any number of times, which such sale or lease shall be made at public auction at such place in the county in which the property the sold is structed and at such time and upon such terms as may be fixed by the City and briefly specified in the notice of such sale or sales. Any sale by the City may nevertheless, at its option, be made at such other place or places, and in such other manner, as may now or hereafter be authorized by law.
- 13. The receipt of the City or of the court officer conducting any such sale for the purchase money paid at any such sale shall be a sufficient discharge therefor to any purchaser of the property, or any part thereof, sold as aforesaid; and no such purchaser or his representatives, grantees or assigns, after paying such purchase money and receiving such receipt, shall be bound to see to the application of such purchase money upon or for the purpose of this Mortgage, or shall be answerable in any manner whatsoever for any loss, misapplication or non-application of any such purchase money or any part thereof, nor shall any such purchaser be bound to inquire as to the necessity or expediency of any such sale.
- 14. The purchase money proceeds or avails of any such sale, together with any other sums which then may be held by the City under the Mortgage as part of the property or the proceeds thereof, whether under the provisions of this Article or otherwise, shall be paid to the City who shall apply such funds as follows:

FIRST: To the payment of the costs and expenses of such sale, including reasonable compensation to the City, its agents, attorneys and counsel, and the expenses of any judicial proceedings wherein the same may be made, and of all expenses, liabilities and advances made or incurred by the

City as permitted by this Mortgage, and to the payment of all taxes, assessments or liens prior to the lien of this Mortgage, except any taxes, assessments, liens, or other charges, subject to which the property shall have been sold.

SECOND: To the payment of the whole amount of the obligations.

THIRD: To the Payment of any other sums required to be paid by the Owner pursuant to any provisions of the Mortgage.

FOURTH: To the payment of the surplus, if any, to the Owner or its successors or assigns, upon the written request of the Owner or to whomsoever may be lawfully entitled to receive the same upon its written request, or as any court of competent jurisdiction may direct.

- 15. The Owner further covenants that upon the happening of any Event of Default and thereafter during the continuance of such Event of Default unless the same shall have been waived as hereinbefore provided, the city shall be entitled as a matter of right if it shall so elect at any time to the appointment or a receiver or receivers of the property and of it he earnings, revenues, rents, issues, profits and income thereof, with such powers as the court making such appointment shall confer, which may comprise any or all of the powers which the City is authorized to exercise. The Owner, if requested so to do by the City, will consent to the appointment of any such receiver as aforesaid.
- 16. No remedy herein conferred upon or reserved to the City is intended to be exclusive of any other remedy or remedies, and each and every such remedy shall be cumulative, and shall be in addition to every other remedy given hereunder or now or hereafter existing at law or in equity or by statute.
- 17. No delay or omission of the City to exercise any right or power accruing upon any event of default shall impair any such right or power, or shall be construed to be a waiver of any such event of default or any acquiescence therein; and every power and remedy given by this Mortgage to the City may be exercised from time to time and as often as may be deemed expedient to the City.
- 18. To the extent permitted by law, the Owner will not during the continuance of any Event of Default hereunder insist upon, or plead, or in any manner whatever claim or take any benefit or advantage of, any stay or extension law wherever enacted, now or at any time hereafter in force, which may affect the covenants and terms of performance of this Mortgage; nor claim, take or insist upon any benefit or advantage of any law now or thereafter in force providing for the valuation or appraisement of the Mortgage. The property or any part thereof, prior to any sale or sales thereof which may be made pursuant to any provisions herein contained, or pursuant to the decree, judgment or order of the court of competent jurisdiction; nor after any such sale or sales, claim or exercise any right under any statute heretofore or hereafter enacted by the

United States of America or by any state or territory, or otherwise, to redeem the property so sold or any part thereof; and the Owner hereby expressly waives all benefits or advantage of any such law or laws and covenants not to hinder, delay or impede the execution of any power herein granted or delegated to the City, but to suffer and permit the execution of every power as though no such law or laws had been made or enacted.

- 19. All rights, remedies and power provided by this Article may be exercised only to the extent that the exercise thereof does not violate any applicable provision of law in the premises, and all the provisions of this Article are intended to be subject to all applicable mandatory provisions of law which may be controlling in the premises and to be limited to the extent necessary so that they will not render this Mortgage invalid or unenforceable under the provisions of any applicable law.
- 20. The Mortgagee may from time to time cure each default under any covenant are agreement in any instrument creating a lien upon the mortgaged property, or any part thereof, which shall have priority over the lien of this Mortgage, each smount paid (if any) by the Mortgagee may exclusively determine, and each amount paid (if any) by the Mortgagee to ture any such default shall be paid by the Mortgager to the Mortgagee; and the Mortgagee shall also become subrogated to whatever rights the holder of the prior lien might have under
- 21. (a) After the happening of any default hereunder, the Mortgagor shall upon demand of the Mortgagee, surrender possession of the mortgaged property to the Mortgagee, and the Mortgagee may enter such property, and let the same and collect all the rents therefrom which are due or to become due, and apply the same, after payment of all charges and expenses, on account of the indebtedness hereby secured, and all such rents and all leases existing at the time of such default are hereby assigned to the Mortgagee as further security for the payment of the indebtedness secured hereby; and the Mortgagee may also dispossess, by the usual summary proceedings, any tenant defaulting in the payment of any rent to the Mortgagee.
- (b) In the event that the Mortgagor occupies the mortgaged property or any part thereof, the Mortgagor agrees to surrender possession of such property to the Mortgagee immediately after any such default hereunder, and if the Mortgagor remains in possession after such default, such possession shall be as a tenant of the Mortgagee, and the Mortgagor shall pay in advance, upon demand by the Mortgagee, as a reasonable monthly rental for the premises occupied by the Mortgagor, an amount at least equivalent to 1/48th of the original principal sum of the Note, plus the actual amount of the annual ground rent, if any, taxes, assessments, water rates, or governmental charges and insurance premiums payable in connection with the mortgaged property during

such year, and upon the failure of the Mortgagor to pay such monthly rental, the Mortgagor may also be dispossessed by the usual summary proceedings applicable to tenants. This covenant shall become effective immediately upon the happening of any such default, as determined in the sole discretion of the Mortgagee, who shall give notice of such determination to the Mortgagor; and in the case of foreclosure and the appointment of a receiver of the rents, the within covenant shall inure to the benefit of such receiver. This provision shall not affect Mortgagee's rights to foreclose this mortgage or to payment of the amounts secured hereby.

- 22.
