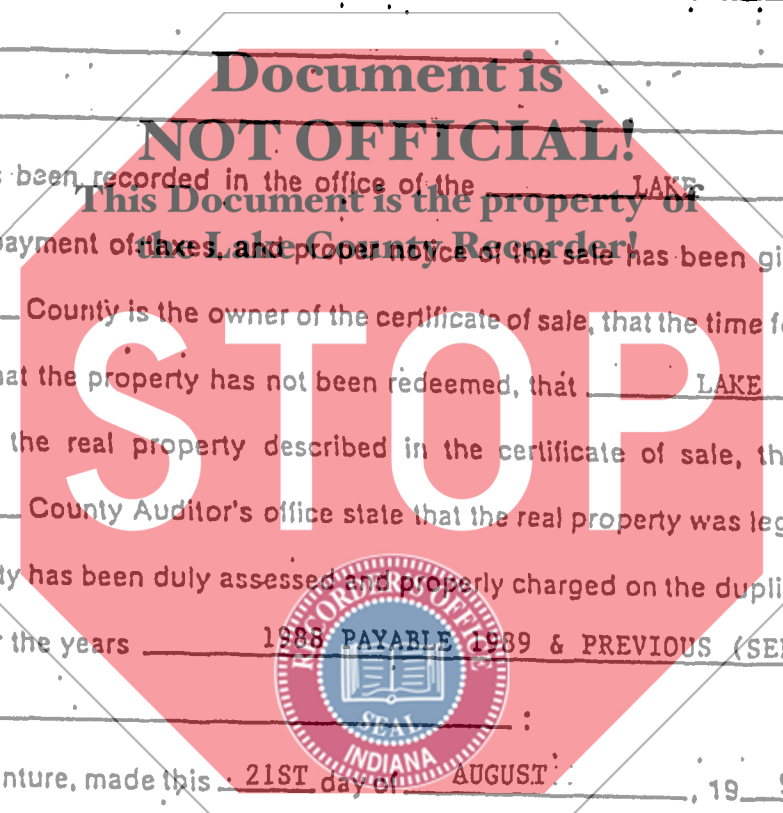

WHEREAS, LAKE County did, on the 18TH day of DECEMBER, 19 89, produce to the undersigned, ANNA N. ANTON, auditor of the county of LAKE, in the state of Indiana, a certificate of sale dated the 18TH day of DECEMBER, 19 89, signed by ANNA N. ANTON, who, at the date of the sale, was auditor of the county, from which it appears that said county on the 18TH day of DECEMBER, 19 89, obtained, pursuant to law, the real property described in this indenture for the sum of ELEVEN THOUSAND NINE HUNDRED EIGHTY FOUR dollars and 63/100 cents,

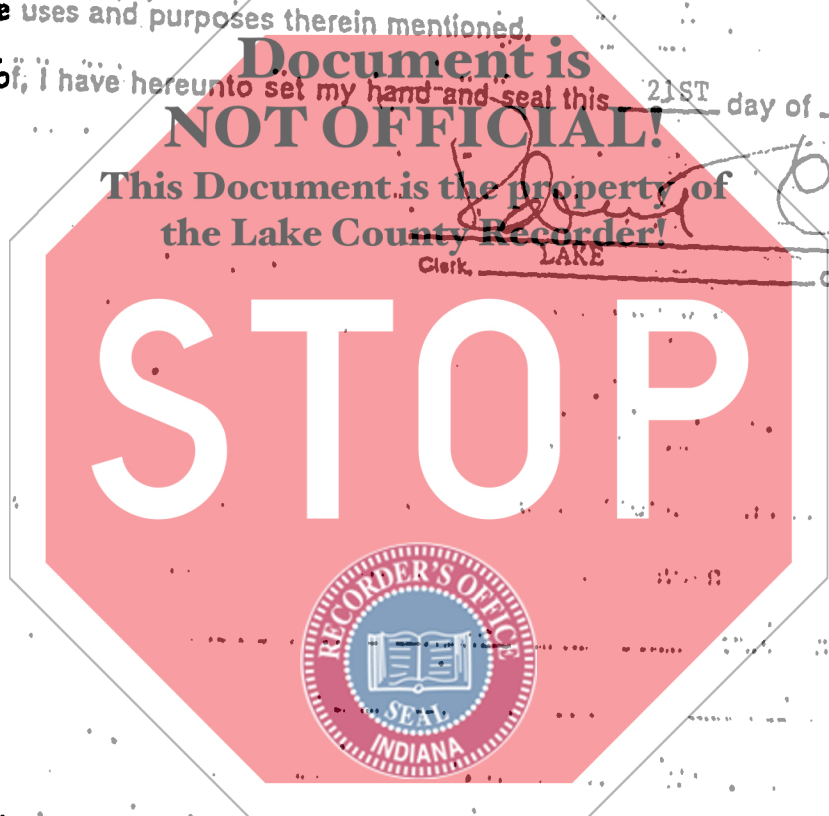
