

ASSIGNMENT OF REAL ESTATE MORTGAGE

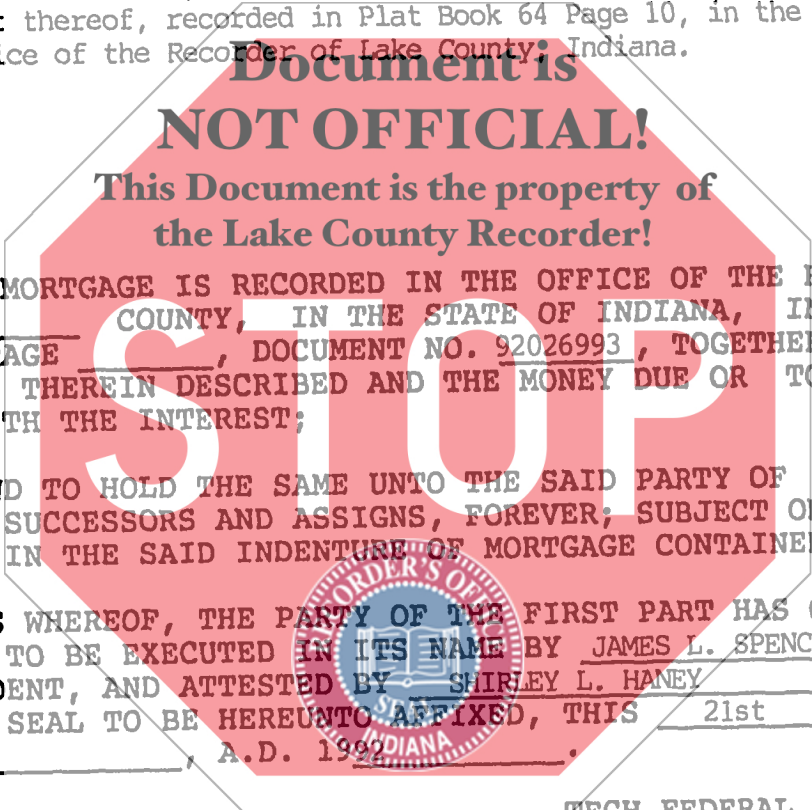
