A parcel of land located in the East Half of the Southeast Quarter of Section 5, Township 36, Range 9, West of the Second Principal Meridian described as follows: Commencing at a point 30 feet North of the South line of Section 5-36-9 and 17.65 feet West of the Southeast corner of said Section 5 proceed Northerly at right angles with said South line a distance of 128.60; thence Northeasterly at an angle of 146 degrees 13 minutes a distance of 118.30 feet more or less to the southwesterly line of Summer Street; thence Northwesterly along the Southwesterly line of Summer Street a distance of 350.0 feet to the place of beginning; thence proceed Northwesterly along the Southerly line of said street a distance of 150 feet more or less to a point which is 541.77 feet Southeasterly from the intersection of the Southerly line of Summer Street and the West line of the East Half of the Southeast Quarter of said Section 5; thence proceed Southwesterly a distance of 420 feet, more or less to a point on the Northerly right of way line of the New York, Chicago and St. Louis Railroad said point being 150 feet Southeast of a point which is 100 feet East measured at right angles to the West line of said Southeast Quarter and on the Northerly right of way of said railroad; then proceed Southeast along said right of way a distance of 270 feet more or less to the Northerly line of 165th Street; thence proceed 422 feet more or less to the place of beginning.
