Tenore, had notice of the filing of summons and Complaint herein; that more than twenty-three (23) days have elapsed since service of Complaint and Summons; and that Defendants, have failed to answer or otherwise plead on Plaintiff's Complaint;

IT IS HEREBY ORDERED, ADJUDGED AND DECREED on Plaintiff's Complaint that Judgment be entered in favor of Plaintiff, Real Estate Management Investment Corporation, As Agent for S & S Properties, d/b/a Cherrywood Trace Townhomes and against Defendants, Judith E. Tenore and Richard L. Tenore, in the amount of \$2225.50, plus attorney's fees in the amount of \$600.00, plus costs of this action incurred to date in the amount of \$38.08 and additional, undetermined costs which may be incurred in the collection of herein action. Court now enters Judgment in favor of Plaintiff, Real Estate Management Investment Corporation, As Agent for S & S Properties, d/b/a Cherrywood Trace Townhomes and against Defendants, Judith E. Tenore and Richard L. Tenore, in the sum of \$2863.58 (with interest from the date hereof at current statutory rate of 10% per annum).

JUDGMENT ACCORDINGLY.

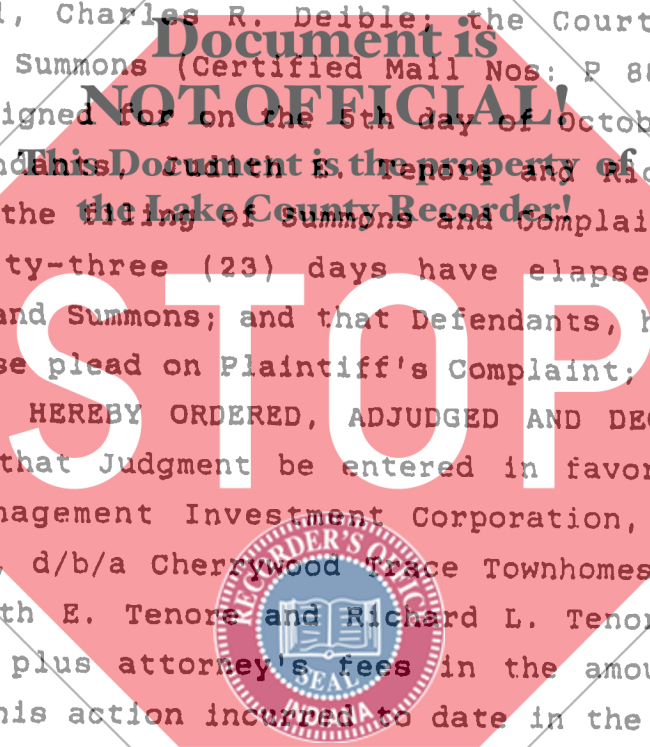
