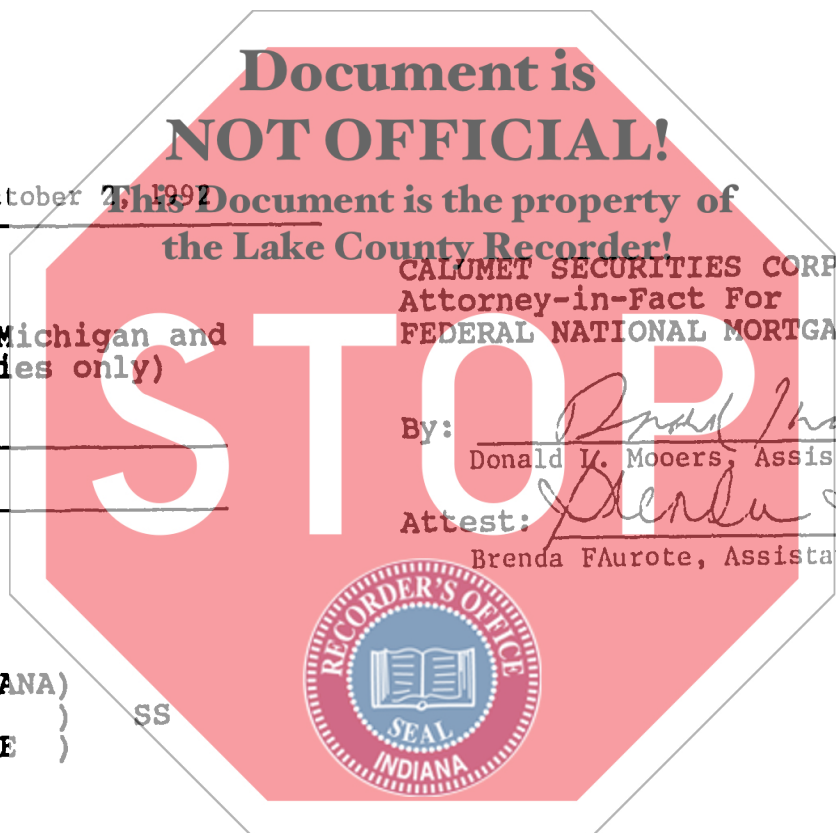
# SATISFACTION OF MORTGAGE
