SATISFACTION OF MORTGAGE

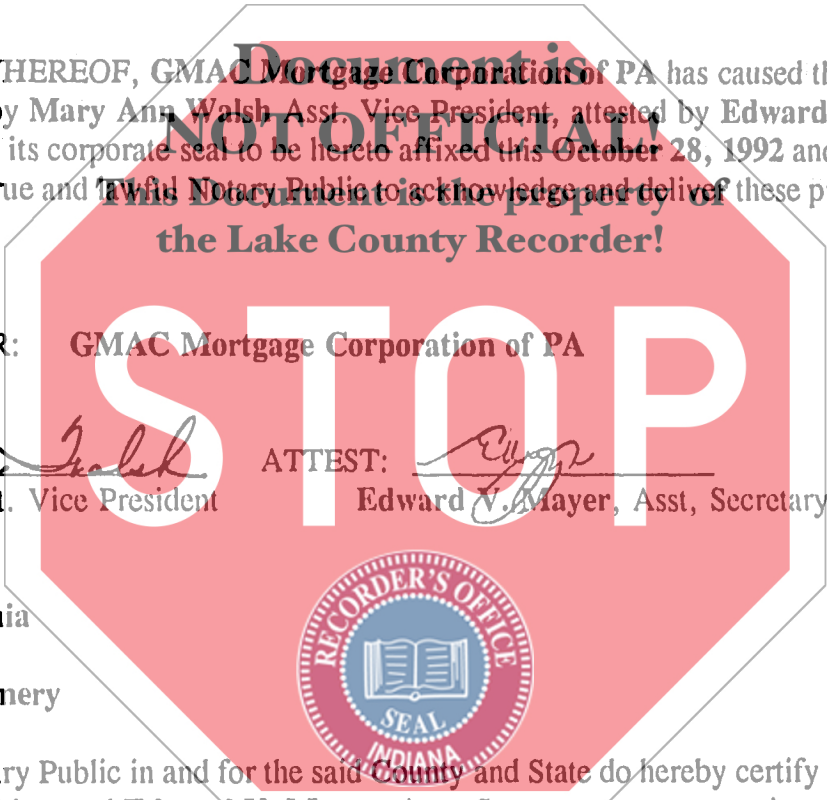
