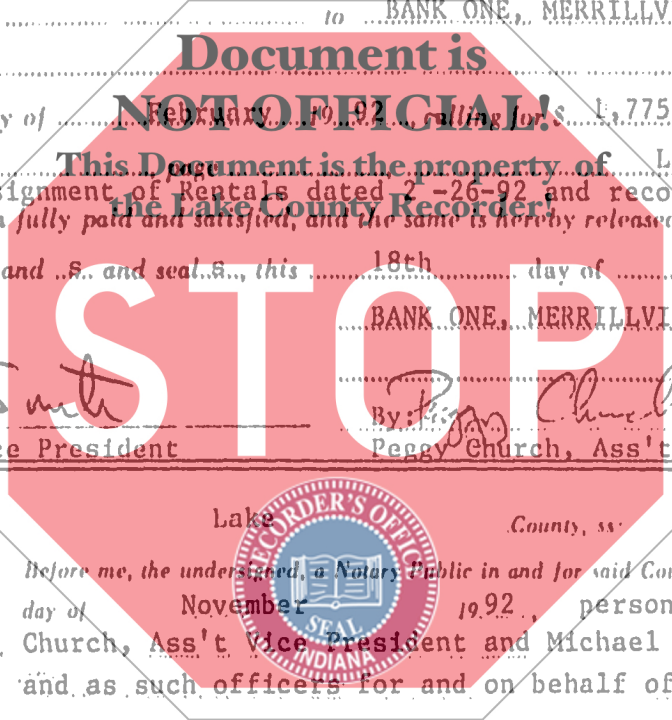
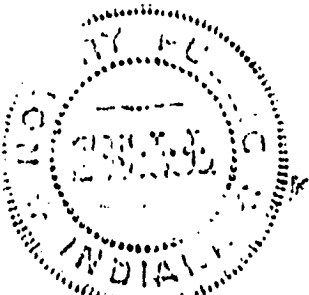

LEGAL DESCRIPTIONS

Parcel 1: The South 3/4 of the Northeast Quarter of the Southwest Quarter except a strip of land 50 feet in width off of the entire East side of the South 3/4 of the Northeast Quarter of the Southwest Quarter, which was heretofore owned by the Gary and Southern Traction Company, and all of said land being in Section 29, Township 35 North, Range 8 West of the 2nd P.M., in Lake County, Indiana.
