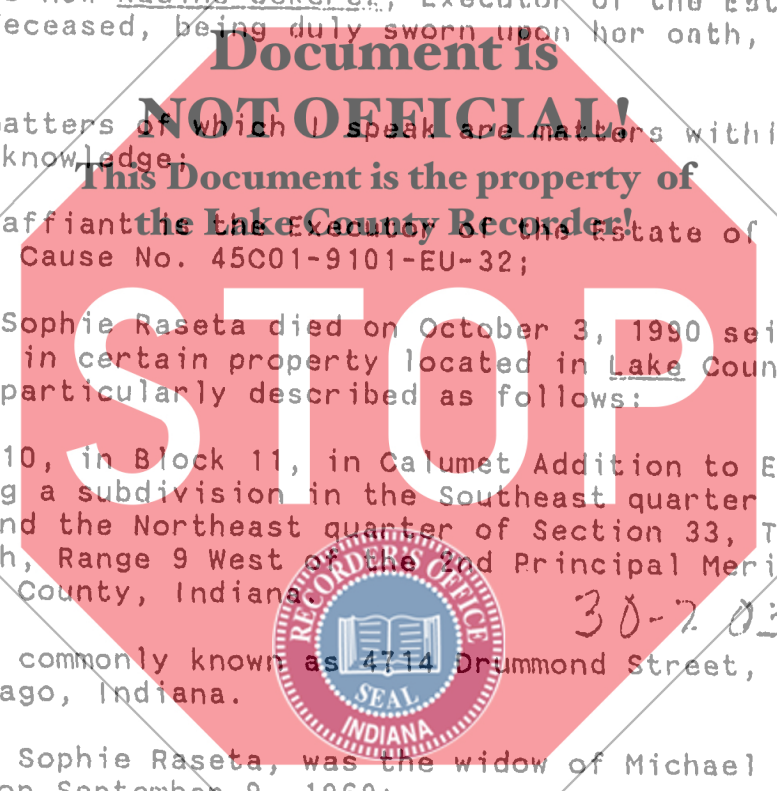

- 1) The matters of which I speak are matters within my own personal knowledge;
- 2) That affiant is the Executor of the Estate of Sophie Raseta, deceased, Cause No. 45C01-9101-EU-32;
- 3) That Sophie Raseta died on October 3, 1990 seized in domusno as of fee in certain property located in Lake County, Indiana, and more particularly described as follows:

 Lot 10, in Block 11, in Calumet Addition to East Chicago, being a subdivision in the Southeast quarter of Section 28 and the Northeast quarter of Section 33, Township 37 North, Range 9 West of the 2nd Principal Meridian, in Lake County, Indiana.

 More commonly known as 4714 Drummond Street, East Chicago, Indiana.
- 4) That Sophie Raseta, was the widow of Michael L. Raseta, Sr. who died on September 9, 1969;
- 5) That Michael L. Raseta, Sr. and Sophie Raseta, held title to said real estate until the death of Michael L. 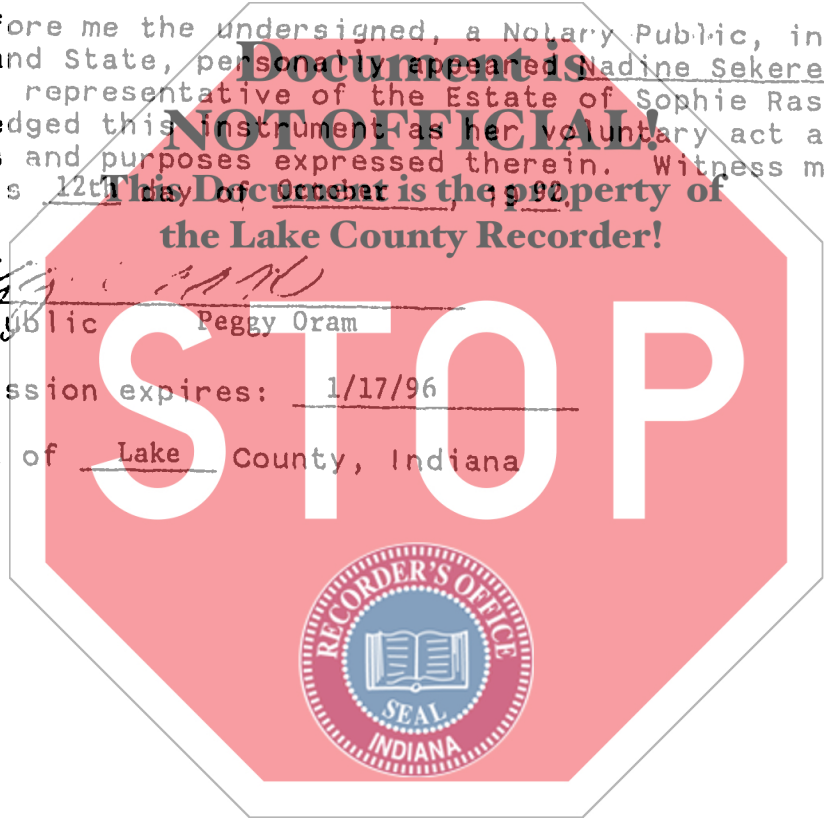
