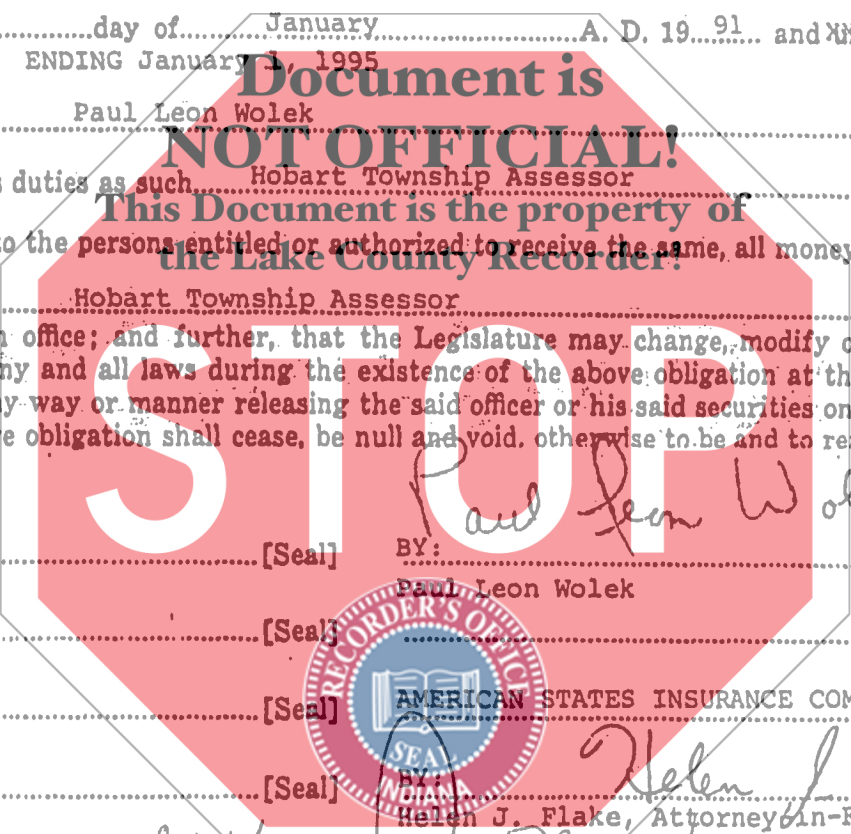
KNOW ALL MEN BY THESE PRESENTS, That we, PAUL LEON WOLEK, Hobart, IN as
