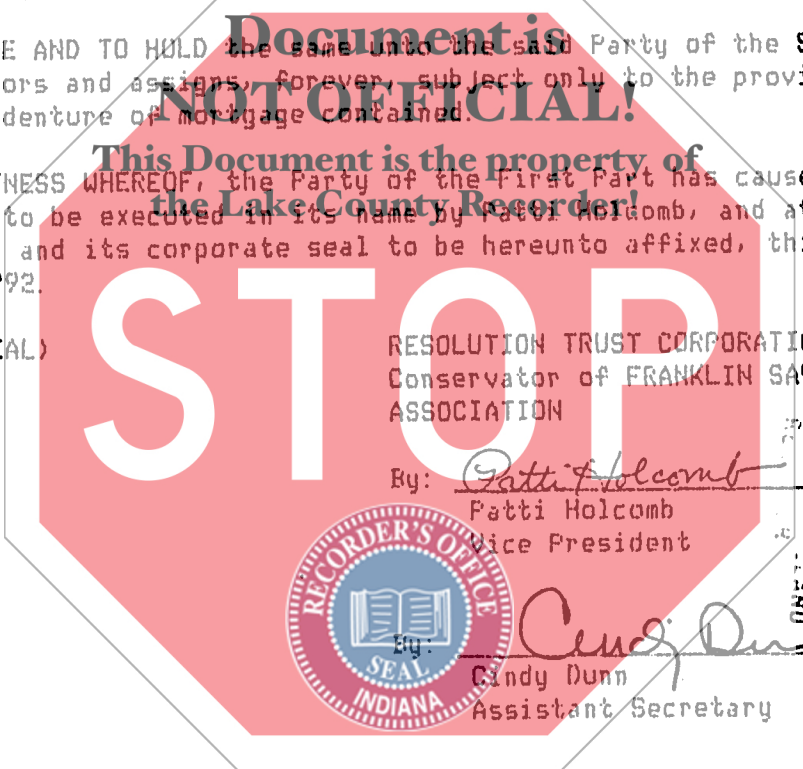
ASSIGNMENT OF REAL ESTATE

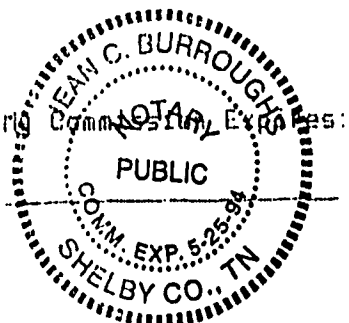
