

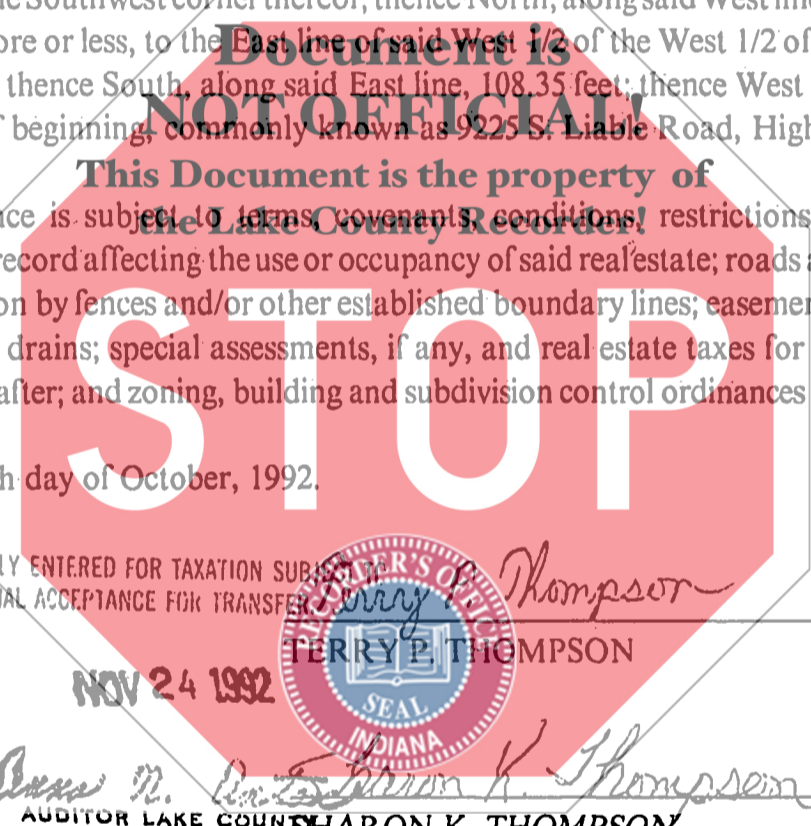

THIS INDENTURE WITNESSETH that the Grantors, TERRY P. THOMPSON and SHARON K. THOMPSON, of the County of Lake and State of Indiana, for and in consideration of Ten and 00/100 (\$10.00) Dollars, and other good and valuable considerations in hand paid; CONVEY and WARRANT unto TERRY PAUL THOMPSON, as Trustee under the provisions of a Trust Agreement known as the "Terry Paul Thompson Trust" dated the 8th day of October, 1992, the following described real estate in the County of Lake and State of Indiana, to-wit: *KEY 27-17-66*

Part of the West 1/2 of the West 1/2 of the Southwest 1/4 of the Northeast 1/4 of Section 27, Township 36 North, Range 9 West of the 2nd Principal Meridian, in the Town of Highland, Lake County, Indiana, described as follows: Beginning at a point on the West line of said Northeast 1/4 and 325.05 feet North of the Southwest corner thereof; thence North, along said West line, 108.35 feet; thence East 332.89 feet, more or less, to the East line of said West 1/2 of the West 1/2 of the Southwest 1/4 of the Northeast 1/4; thence South, along said East line, 108.35 feet; thence West 332.80 feet, more or less, to the point of beginning, commonly known as 9225 S. Liable Road, Highland, Indiana.
