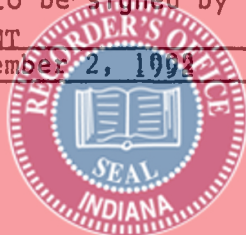
SUBJECT TO THE FOLLOWING:

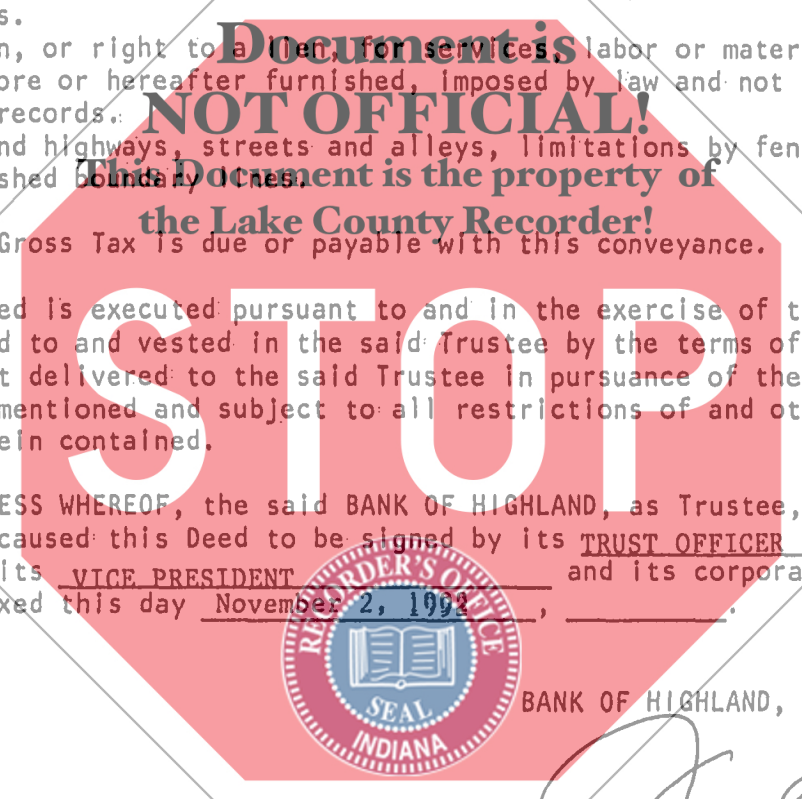
