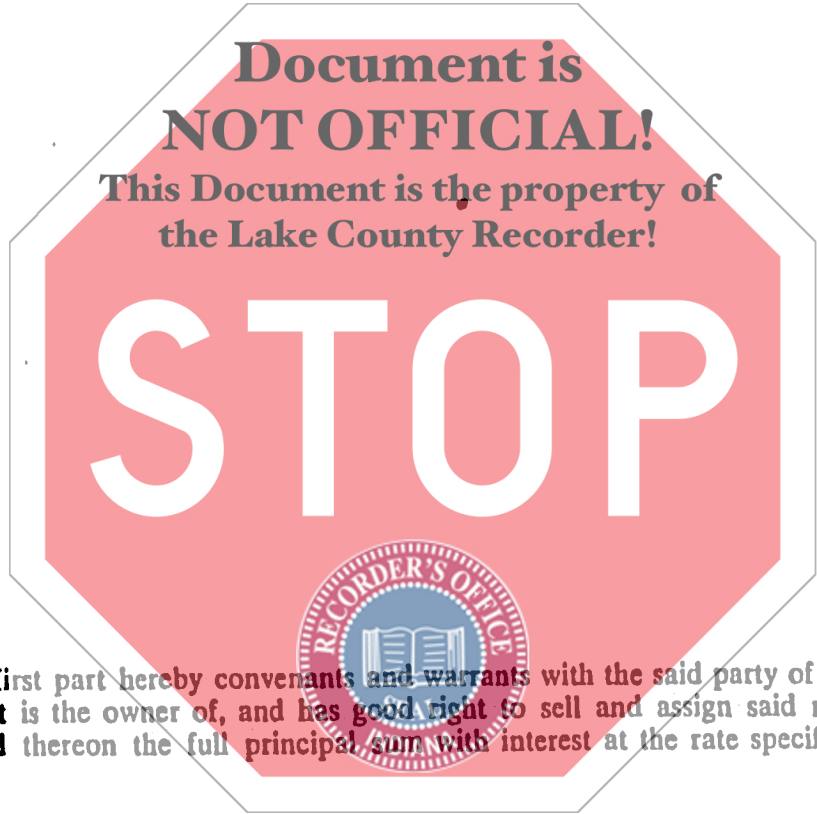
Assignment of Mortgage
