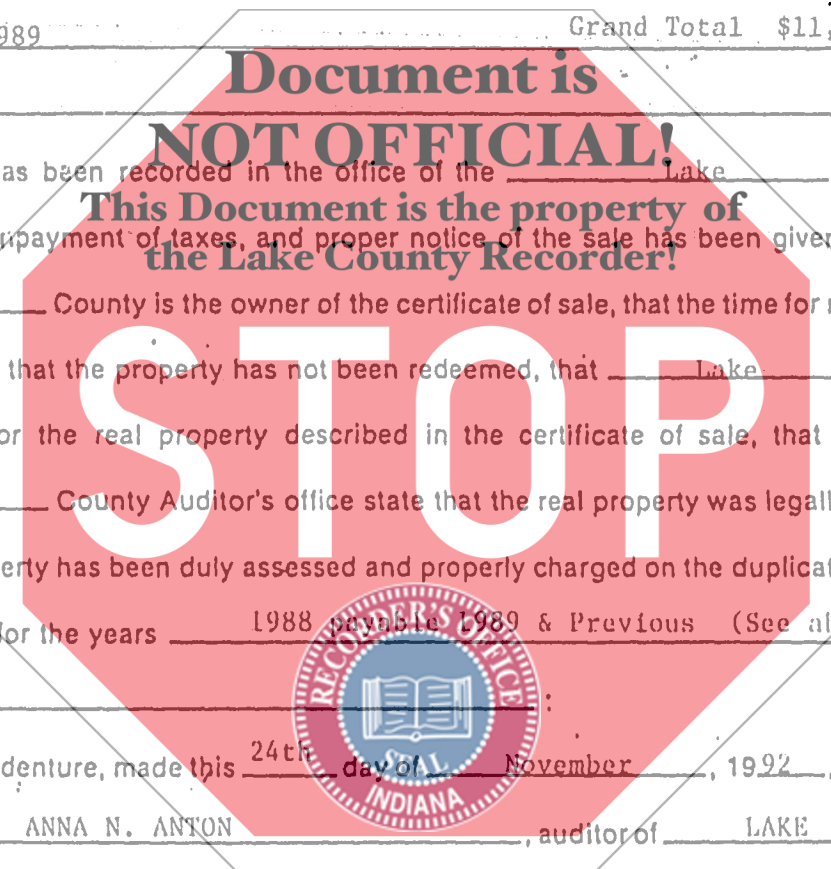


TAX TITLE DEED TO COUNTY

WHEREAS, LAKE County did, on the 18th day of DECEMBER, 1992, produce to the undersigned, ANNA N. ANTON, auditor of the county of LAKE, in the state of Indiana, a certificate of sale dated the 18th day of December, 1989, signed by ANNA N. ANTON, who, at the date of the sale, was auditor of the county, from which it appears that said county on the 18th day of DECEMBER, 1989, obtained, pursuant to law, the real property described in this indenture for the sum of (\$ 7,618.81) Seven thousand Six Hundred Eighteen dollars and 81/100 cents, being the amount due on the real property for taxes, special assessments, penalties and costs for the years 1988 Payable 1989 & Previous, namely:

1986 Payable 1987 (Additional Amount of Taxes Added to Property
1987 Payable 1988 Since County Aquired Lien \$4,174.31
1988 payable 1989 Grand Total \$11,793.12



Such real property has been recorded in the office of the Lake County Auditor as delinquent for the nonpayment of taxes, and proper notice of the sale has been given. It appearing that Lake County is the owner of the certificate of sale, that the time for redeeming such real property has expired, that the property has not been redeemed, that Lake County has demanded a deed for the real property described in the certificate of sale, that the records of the Lake County Auditor's office state that the real property was legally liable for taxation, and that the real property has been duly assessed and properly charged on the duplicate with the taxes and special assessments for the years 1988 payable 1989 & Previous (See above)

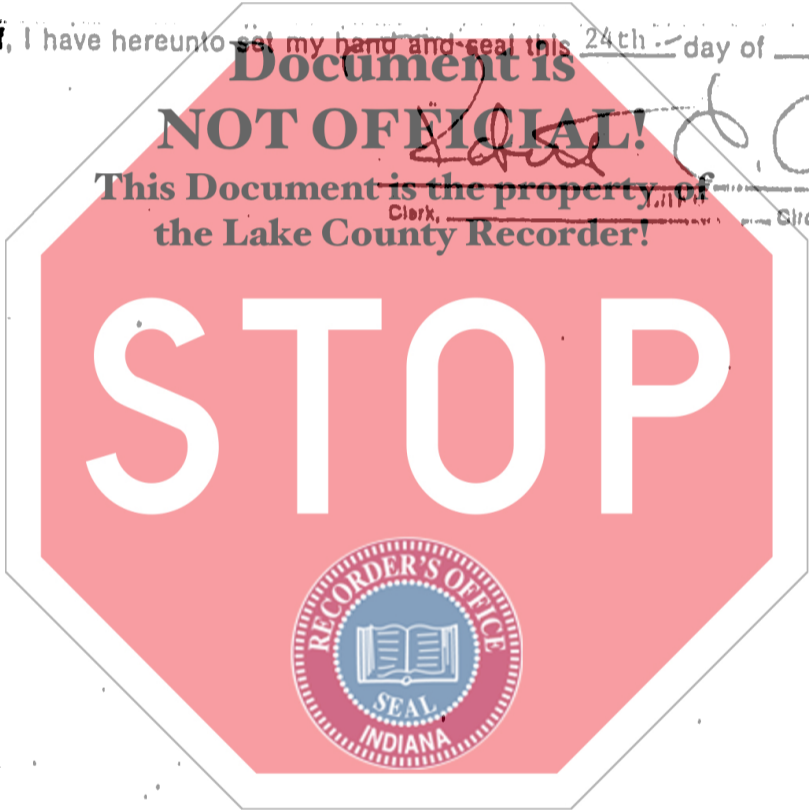
