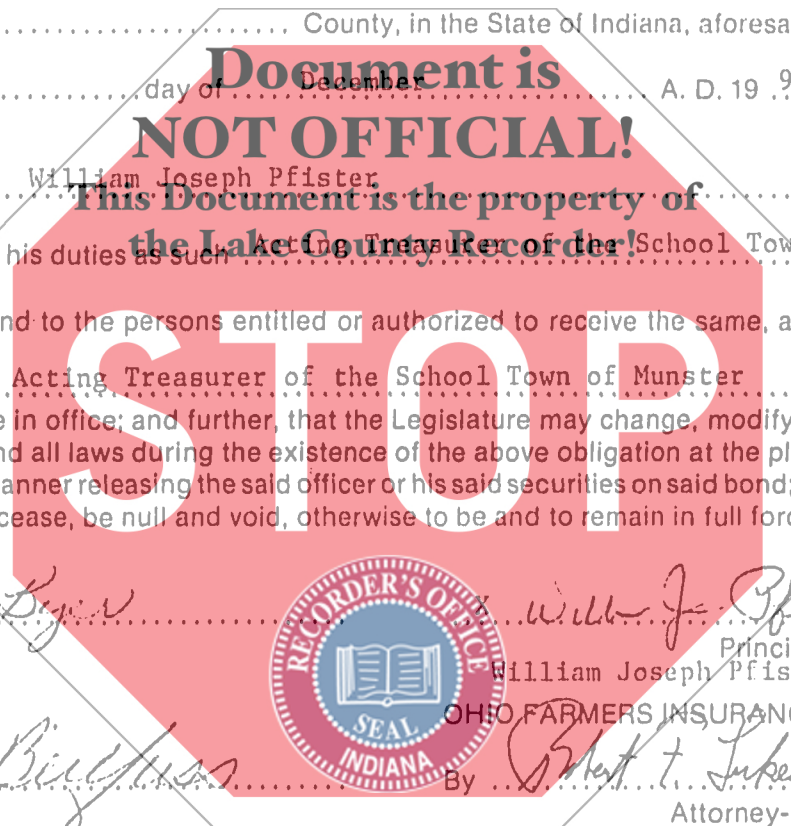

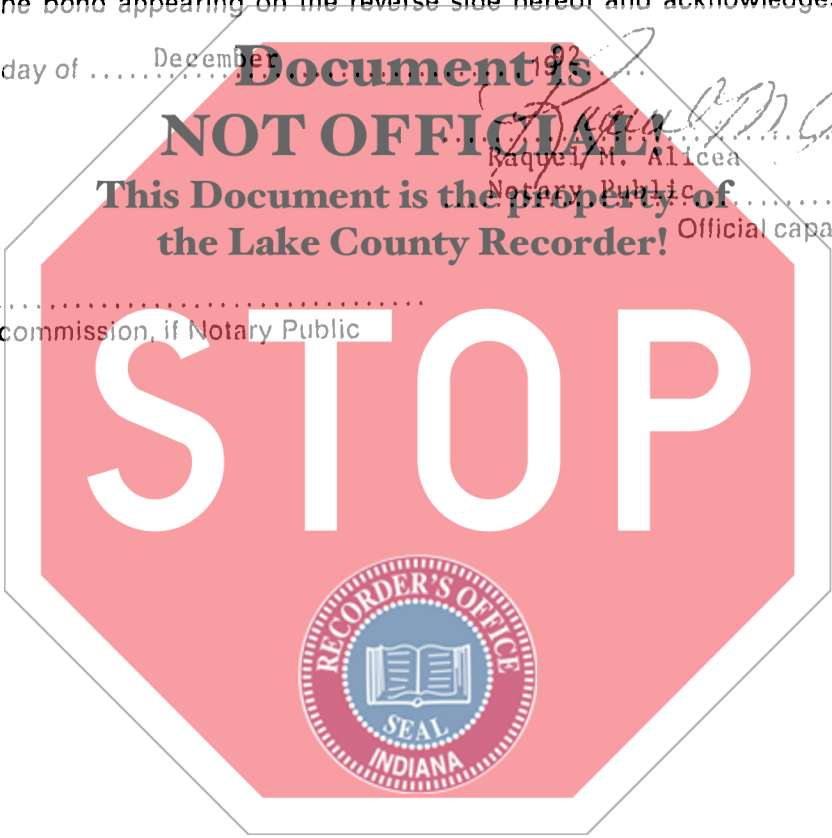

GESCHIEDLER, JR., R. J. GESCHIEDLER, CLYDE E. RECTOR, ROBERT F. JOHN, JOHN H. GESCHIEDLER, GEORGE KARPINEC, JOINTLY OR SEVERALLY

of HAMMOND and State of IN its true and lawful Attorney(s)-in-Fact, with full power and authority hereby conferred in its name, place and stead, to execute, acknowledge and deliver any and all bonds, undertakings, and recognizances; provided, however, that the penal sum of any one such instrument executed hereunder shall not exceed FIVE MILLION DOLLARS AND NO CENTS (\$5,000,000)....
