- 3) CAROL VANDERNOODE, living over the age of 18 and competent.

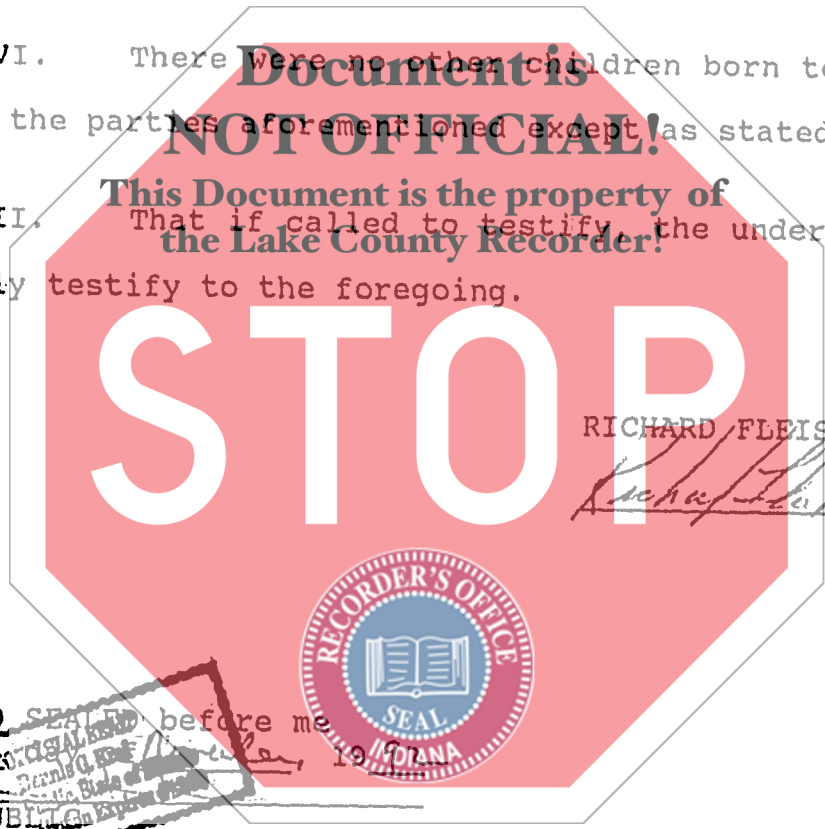
- D) RICHARD FLEISHMAN, living over the age of 18 and competent.
