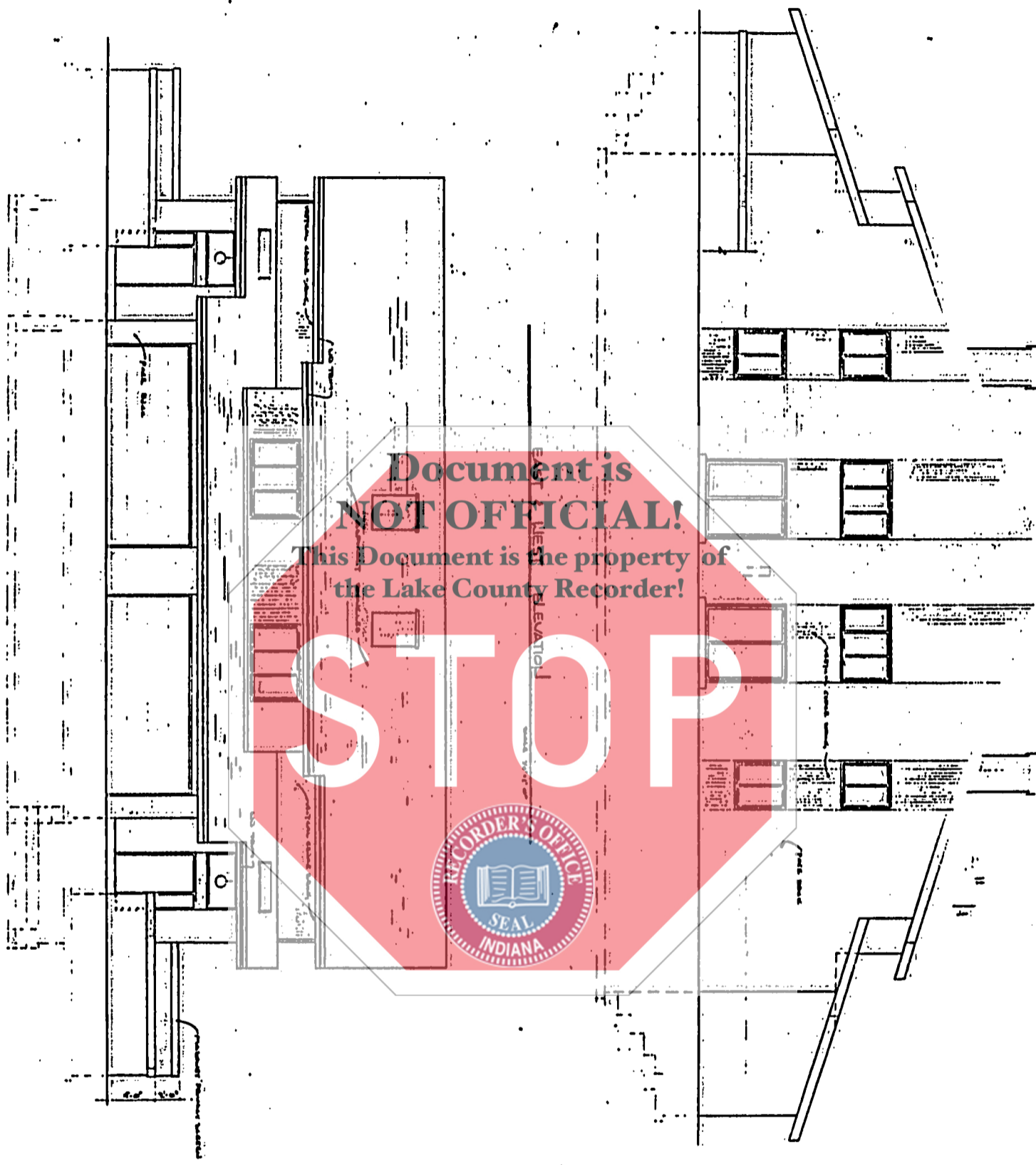

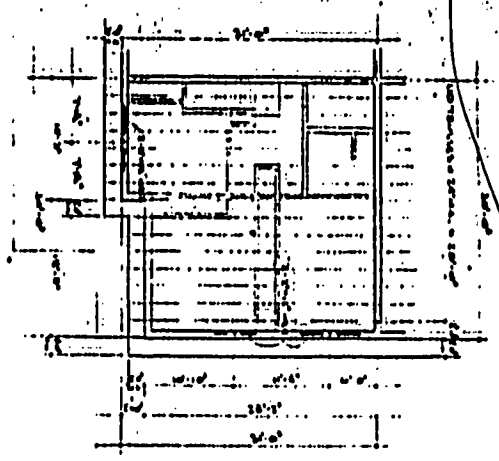

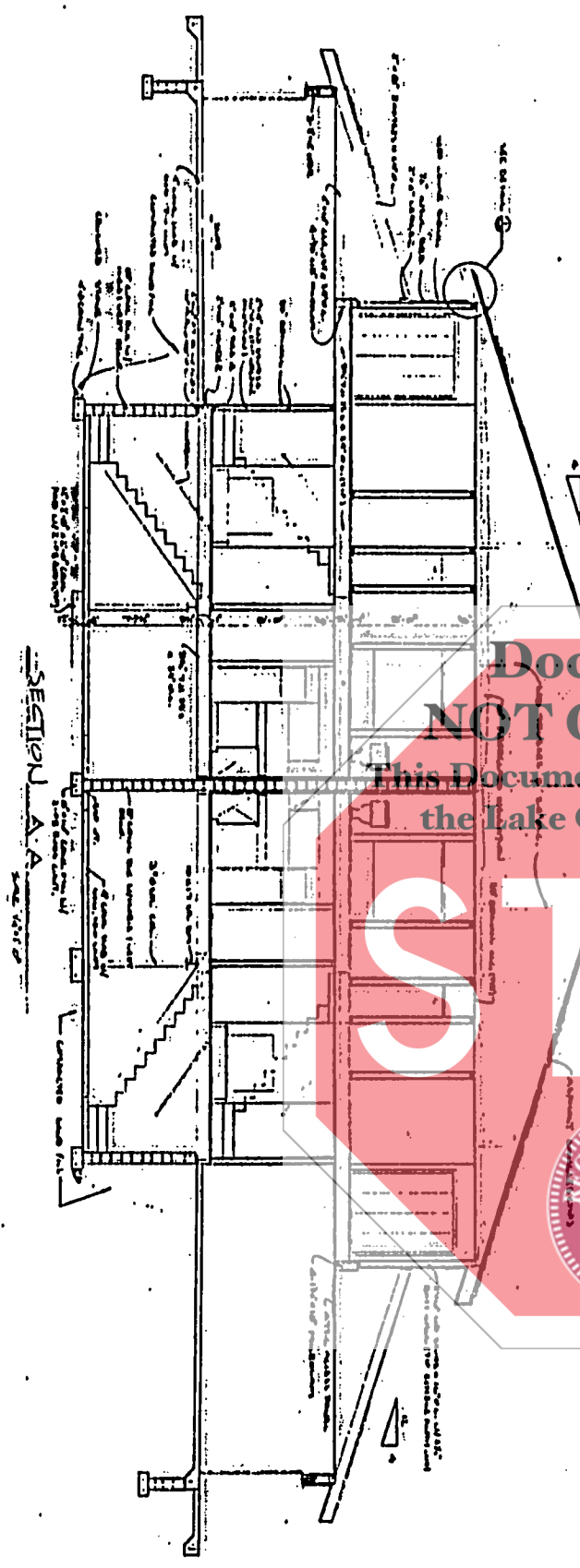

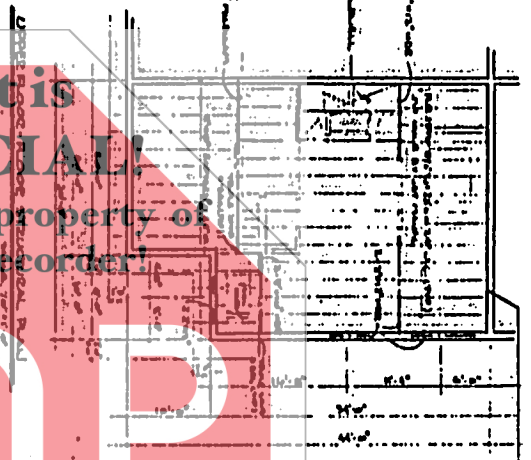




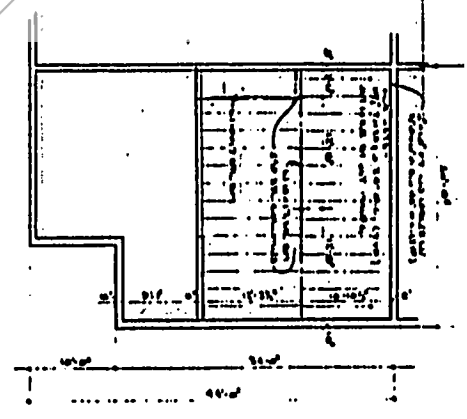
ROOF STRUCTURAL PLAN



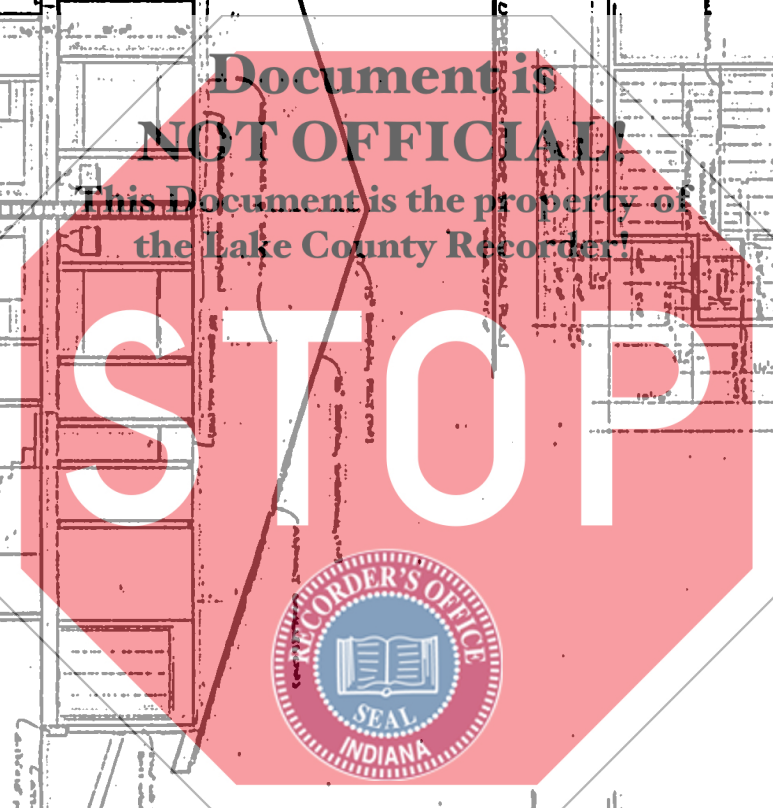
SECTION A-A

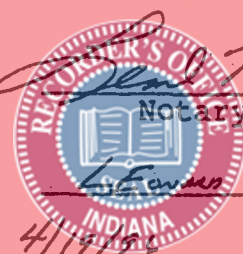
