# Assignment of Mortgage

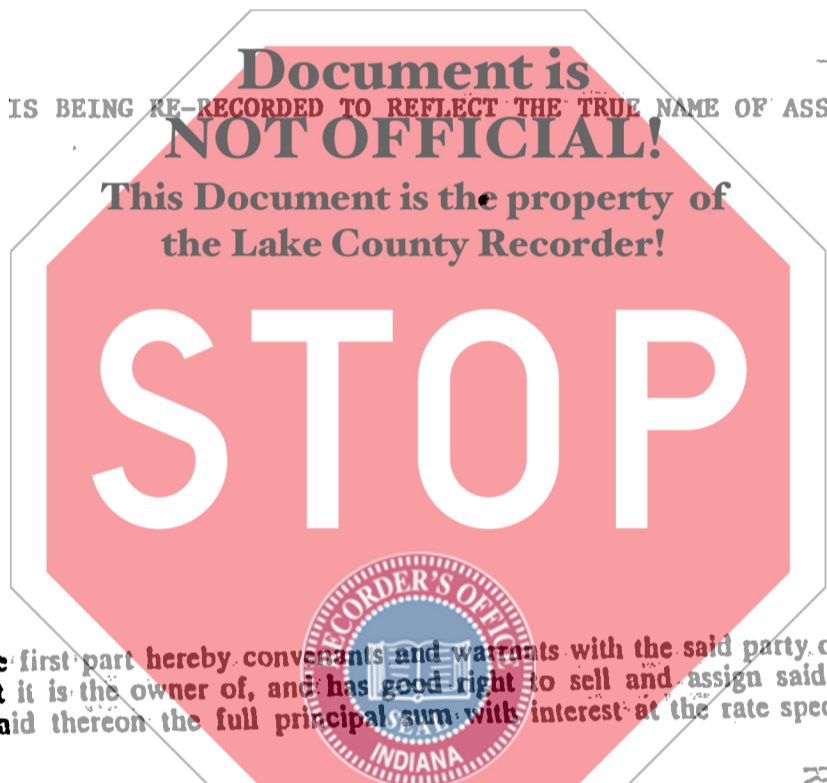
