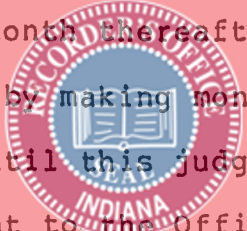
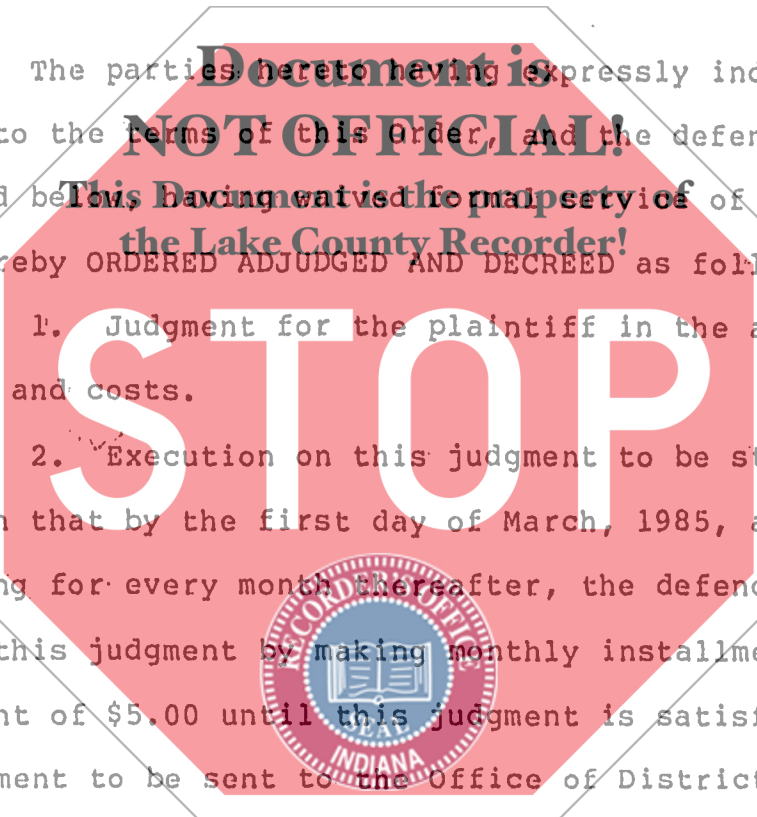

CONSENT JUDGMENT

The parties hereto having expressly indicated their consent to the terms of this order, and the defendant, as indicated below, having waived the majority of the complaint, it is hereby ORDERED ADJUDGED AND DECREED as follows:

- Judgment for the plaintiff in the amount of \$907.61, and costs.
- Execution on this judgment to be stayed on the condition that by the first day of March, 1985, and continuing for every month thereafter, the defendant shall satisfy this judgment by making monthly installment payments in the amount of \$5.00 until this judgment is satisfied in full. Such payment to be sent to the Office of District Counsel (02), Veterans Administration, 575 N. Pennsylvania Street, Indianapolis, Indiana 46204.

3. In the event the defendant defaults in the payment of any installment due under this Order, plaintiff may execute on the remaining balance of this judgment with interest thereon at the legal rate from the date of the filing of the Consent Judgment and the costs of this action, after notice to the defendant and the Court of its intentions to do so.

4. Notice to the defendant pursuant to paragraph three above shall be deemed due and sufficient notice when sent by first class mail.

5. And the costs of this action are assessed against the defendant.
