1. That they are the owners of certain real estate located in Lake County, Indiana legally described as:

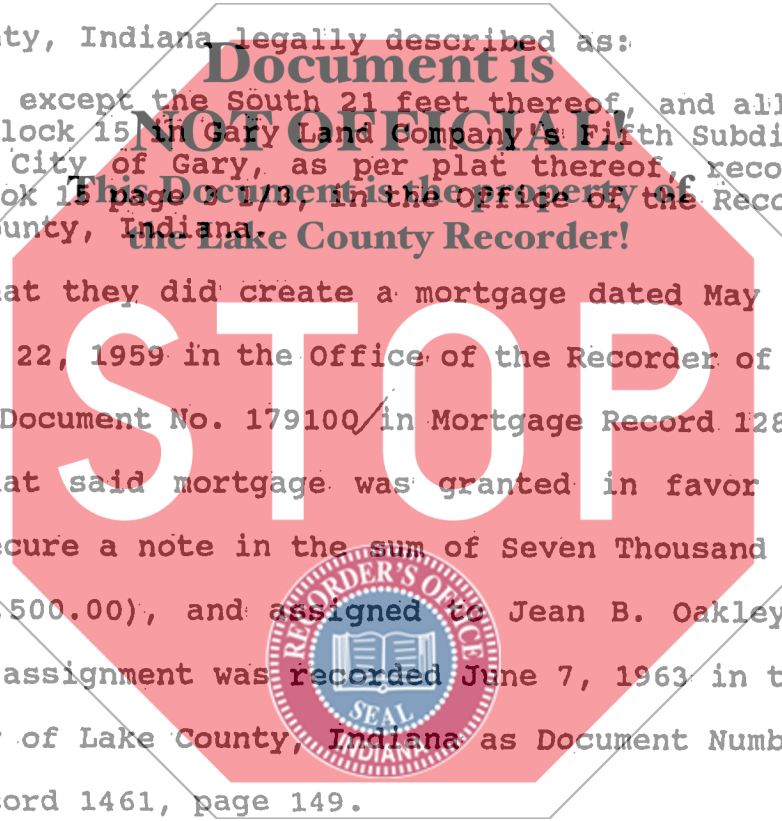
