THYBURN ZIMMERMAN, Adult Daughter, who, on the 7th day of January, 1967, filed her disclaimer of any interest in the intestate share of decedent's estate, and that said decedent died unmarried, leaving no other child or children, nor descendants of any predeceased child or children, other than those named above.

6. That the property owned in certain place of real estate located at 336 East 55th Place, Merrillville, Indiana, more particularly, described as follows:

Lots 15 and 16 in Block 36 in Southlands Third Subdivision in the Town of Merrillville as per plat thereof recorded in Plat Book 19, page 34, in the Office of the Recorder of Lake County, Indiana, the property commonly known as 336 East 55th Place, Merrillville, Indiana 46410,

and that upon the death of said decedent, said real estate vested by the laws of Intestacy in FRANCES L. THYBURN, daughter to the decedent.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Court as follows:

1. Said Final Report and Account of said Administratrix is hereby in all things approved, ratified and confirmed.

2. That the distribution of the balance of the property remaining in said Administratrix's hands for distribution has been made pursuant to the distribution set forth in the final accounting and is hereby in all things approved.

3. That pursuant to the laws of Intestacy the following described real estate, to-wit:

Lots 15 and 16 in Block 36 in Southlands Third Subdivision in the Town of Merrillville as per plat thereof recorded in Plat Book 19, page 34, in the Office of the Recorder of Lake County, Indiana, the property commonly known as 336 East 55th Place, Merrillville, Indiana 46410,

is hereby vested in FRANCES L. THYBURN in fee simple.

And that said Administratrix is hereby directed to procure and record in the Office of the Recorder of Lake County, being the county in which said real estate is located, a certified copy of this Final Decree.

4. Said Administratrix having made distribution of all assets and property and having attached vouchers evidencing said distribution to the decedent's heirs, said distribution is hereby approved and confirmed.

5. Said Administratrix is hereby released and discharged from any further liability or responsibility along with her surety as said Administratrix of the Estate of IRVING TICHMAN. All of which is ordered this 1st day of July, 1960.
