together with the tenements, appurtenances and rights thereto belonging, together with the rents therefrom, to secure the payment of one promissory note, of even date, in the amount of Twelve Thousand Seven Hundred Seventy Six & 40/100 DOLLARS, (\$12,776.40), made and executed by the mortgagor, payable to the order of the mortgagee, in accordance with the terms as set out in said promissory note.

In the event of a proceeding to foreclose this mortgage, the Mortgagor agrees to pay reasonable attorneys' fees and such other expenses necessarily a part of such proceeding.

The lien of this mortgage shall include all equipment and appliances located on said real estate whether now or hereafter attached to or used in said real estate.
