THIS SECOND AMENDMENT TO THIS TRUST AGREEMENT is executed this 10th day of July, 1992, by ALPHON L. CORNET, as Grantor, and ALPHON L. CORNET, as Trustee.

WHEREAS, under date of August 6, 1987, ALPHON L. CORNET, as Grantor and ALPHON L. CORNET, as Trustee, executed a Trust Agreement under which the Grantor reserved the right to amend said instrument, and

WHEREAS, the Grantor desires and the Trustee consents to amend the Trust Agreement and does hereby amend the Trust Agreement by omitting Item 2 in its entirety from the Trust Agreement and in lieu thereof the following Item 2 shall be substituted in the Trust Agreement:

Item 2. Appointment of Trustee.

ALPHON L. CORNET shall be appointed as the initial Trustee under this Revocable Trust. Upon the death of ALPHON L. CORNET, his resignation, or in the event that he shall become disabled or incapacitated, physically or mentally, as determined by two (2) medical doctors, then the Grantor's son, ALPHON L. CORNET, JR., shall be appointed successor Trustee. In the event that ALPHON L. CORNET, JR. shall predecease the Grantor, refuse or is unable to qualify as successor Trustee, then Grantor's wife, SADIE M. CORNET, shall be appointed the successor Trustee.

In all other respects the Trust Agreement and the First Amendment to the Trust Agreement shall remain the same.

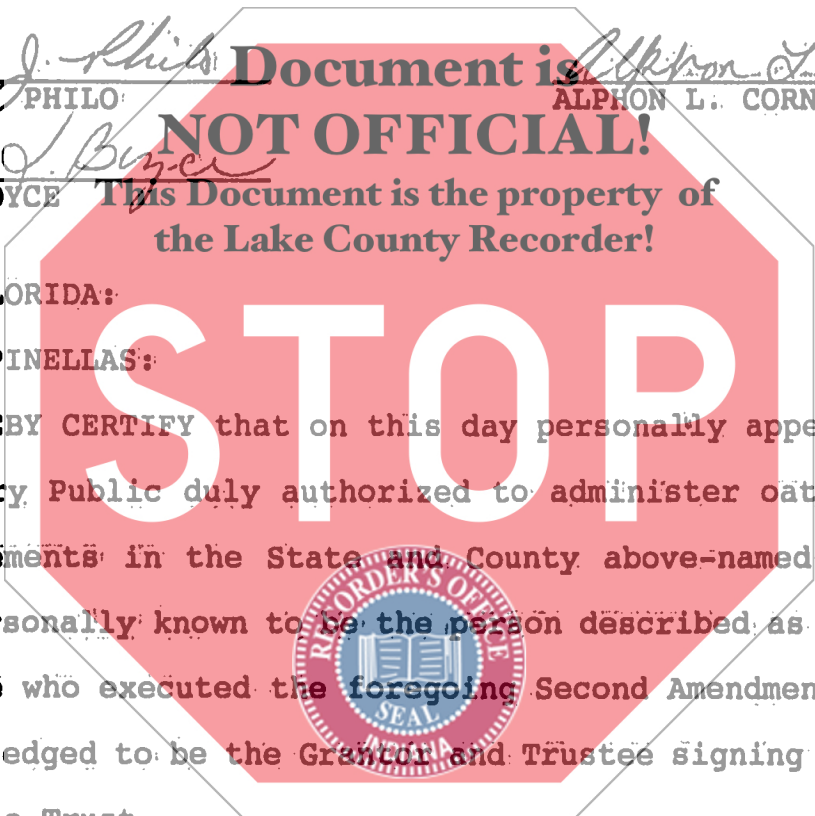
